Sub:- Brutal Murder of Seetharam Naik s/o Hemla Naik ST, (Lambada) r/o Malkapur vg., Koilkonda-M, Mahabubnagar Dist, AP.

Adverting to the above cited subject it is to state that the representation of S. Deva Kumar state Coordinator Sakshi Human Rights Watch, Secunderabad, AP regarding brutal murder of Seetharam Naik r/o Malkapur vg., Koilkonda-M, Mahabubnagar Dist, AP is received for enquiry, relief and compensation.

In this connection it is to state that on 17.07.2008 the SI of Police, Koilkonda PS recorded the statement of complainant Smt. Venkatalaxmi w/o Seetharam Naik in SVS Hospital, Mahabubnagar where in she stated that about a year ago they purchased a open place existing adjacent to their house. By the side of this site, the house of Ram Reddy is located. On 17.07.2008 the said Ram Reddy started construction without leaving a gap (Sheri) in between their houses at about 2:30 PM when her husband Seetharam Naik asked Rajeshwar Reddy s/o Ram Reddy as to why they are constructing without leaving a gap. On which Rajeshwar Reddy beat her husband with a brick on the temporal region, and also with a stick on his head and caused bleeding injuries. Her husband fell unconscious and immediately she admitted in Govt. Hospital, Mahabubnagar and then shifted to SVS Hospital and requested for legal action against Rajeshwar Reddy.

Basing on the statement a case in Cr.No.55/2008 u/s 324 IPC of PS Koilkonda and investigated into.

property)

During the course of investigation on 24.7.2008 the complainant further added that the accused Rajeshwar Reddy while beating her husband on 17.7.2008 he also abused on caste basis. Hence sec. 3(1) (ii) (x) SC/ST (POA) act was added by SI. Subsequently the SDPO Mahabubnagar was appointed as I.O. Further on 31.07.2008 at 0945 hrs. the injured Seetaram Naik was succumbed at SVS Hospital Mahabubnagar while under going treatment. As such sec.of law was altered from 324 IPC, sec. 3(1) (ii) (x) SC/ST (POA) Act 1989 into 302 IPC and sec. 3(1)(x), 3(2)(v) SC/ST (FOA) Act 1989 on 31.7.2008. During further investigation the accused A1 M.Rajeshwar Reddy s/o Ramreddy, 25 yrs., was arrested on 06.08.2008 while the accused A2 M.Ramreddy, 60 yrs., A3.Smt.M.Anantamma, 55 years, and A4 N.Kanthareddy, 19 yrs. all r/o Malkapur vig. were arrested on 18.08.2008 and sent them to judicial remand.

From the evidence collected it is established that the deceased Seetaram Naik purchased adjacent plot to his house about one year ago, by the side of this plot, the house of accused A2 Ramreddy is located who is constructing some rooms without leaving a gap (Shari Sandu). On 17.07.2008 at about 1430 hrs. when the deceased asked A1 to stop the work without leaving gap, the accused A2 to A4 joined A1 and abused the deceased on caste name. Meanwhile A1 Rajeshwar Reddy beat the deceased with a brick on his left temporal region and also beat the deceased on the head with a centering plank and caused him to bleedings injuries. Resulting the deceased lost his consciousness. Soon he was shirted to hospital and while under going treatment, the deceased succumbed to injuries on 31.7.2008.

Under the above circumstances prompt action has already been taken in this case by effecting the arrest of all the accused involved in this case. The case is UI for want of FSL report.
