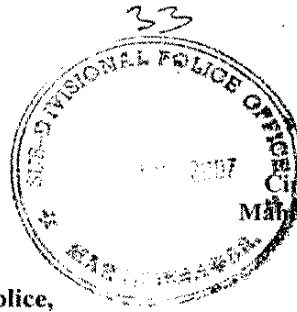

With reference to the above subject I submit that I have received the joint petition of K.Manikyam s/o Punya naik and K.Mogya s/o Punya naik both r/o Thirumalayapally thanda of Koilkonda Mandal which was addressed to President, SC/ST/BC/Minority Welfare Association and National Commission for Scheduled Tribes for my enquiry and report vide reference 1<sup>st</sup> and 2<sup>nd</sup> cited above. The matter pertains to Cr.No.3/2006 U/s 366 IPC, Sec.3(XI) SC/ST (PA) Act 1989 of Koilkonda PS and the following is my detailed enquiry report.

In the petition they alleged that one Golla Raju s/o Thirumalaiah, age 30 years, caste golla, Occu.Agril., R/o Thirumalaiahpally had kidnapped Kum.Bujamma d/o Puniya naik R/o Thirumalaiahpally thanda H/o Thirmalampally vg. They complaint before Police Koilkonda, but so far they have not taken any action. Therefore, the petitioners requested to do justice and take necessary action and also he made allegations against SI and ASI Koilkonda that he was threatened by them when he approached to police station.

As directed I have enquired into the matter, the matter pertains to Cr.No.3/2006 U/s 366 IPC, Sec.3(xi) SC/ST (PA) Act 1989 of Koilkonda PS and the case is being investigated by SDPO Mahabubnagar. The accused Golla Raju and victim girl Kum.Bujamma are still at large. They said to be left the village with their own will and no body responsible for her abduction.

However, on the report of Kadavath Manikyam naik s/o Punya naik, age 23 years, caste Lambada, Occu.Agril., R/o Thirumalampally thanda the above case was registered and investigated into. Both the accused and victim were whereabouts not known, efforts are being continued to trace out them. After tracing both the accused and victim the statement of victim will be recorded to investigate into case since, the victim is a major and not minor.

Further it is submitted that the ~~the~~ allegations leveled in the petition is false and baseless. Neither SI nor ASI threatened the petitioner or abused in filthy language.

However, efforts are continued for tracing out the victim and accused Golla Raju. The original references enclosed herewith and it may kindly be lodged.
