In this regard it is stated that on the complaint of Sh. Meer Singh S/o late Sh. Kundan Lal r/o A-11/176 Indian Airlines Colony Vasant Vihar New Delhi a case vide FIR No. 12/09 U/s 323 IPC & 3(1) (x) of SC/ST Act has been registered on 28.04.2009 at Police Station Domestic Airport, New Delhi. The aforesaid case is being investigated by Sh. Mohd. Irshad Hairder. ACP/Palam Sub-Division on merits. During the course of investigation the scene of alleged atrocity was inspected and site plan prepared. Complainant as well as other PWs were examined, medical report collected, sealed trouser from hospital and other documents were collected from Sh. Meer Singh through seizure memo. Copy of Caste Certificate was sent to the concerned SDM, Bhiwani, Haryana for verification. Further investigation of this case is in progress. A photocopy of FIR is enclosed herewith. T


