Please refer your letter No.DNB/ATROCITY/D&NHAVELI/2008/334/RU-Idated 16.05.2008 forwarding a representation dtd.16.04.2008 of Shri Diliipbhai N.Bhurkud, Bhurkud falia, Dadra and Nagar Haveli, Silvassa on the subject cited above.


In this regard, it is submitted that on 02.04.08, an information was recived from Vinoba Bhave Civil Hospiat, Silvassa that one patient namely Diliipbhai N.Bhurkud was admitted due to assault injuires. Statement of Diliipbhai N.Bhurkud was recorded in the Hospital. At that time he was feeling well & able to give his statement. He stated that (1) Laxman Raviya Ahir (2) Prakash Bala Ahir (3) Kalpesh Raman Ahir (4) Lala Raviya Ahir (5) Jaghu Bala Ahir (6) Pravin Soma Ahir (7) Amrut Bala Ahir (8) Kanti Ramu Ahir (9) Ashwin Soma Ahir all R/o Samarvarni assaulted him over land matter with hand, pipe etc. over land dispute. Accordingly, a criminal case vide FIR No.97/08 u/s 143,147,148,149, 325 IPC was registered on 02.04.2008 at Silvassa Police Station on complaint of Dilipbhai Navjibhai Bhurkud against all the above accused persons. During the course of investigation all accused persons were arrested on 03.04.2008 and produced before the Hon'ble Court & they

were released on bail by the Court. Medical certificate was showing only simple injury; hence Section 307 IPC was not included in this case. On recording the statements of the witnesses, it was revealed that accused persons did not abuse the complainant on his caste and no other accused was involved in this case. After completing the investigation case was chargesheeted vide Ch. No 61/08 dtd. 09.04.2008 & RCC No.43/08. The case is pending trial in the Court of Law.

In this matter, a cross complaint vide Silvassa P.S. FIR No.96/08 u/s 143,147, 323,504,506 IPC was also been registered on 02.04.2008 at Silvassa Police Station on complaint of Shri Sureshbhai Balabhai Ahir R/o. Samarvarni against (1) Dilip Navji Bhurkud (2) Navin Patel (3) Harish Babar & 04 others of Samarvarni village alleging that accused persons assaulted him over land dispute. During the course of investigation accused (1) Harishbhai Babarbai Ahir (2) Navinbhai Keshavbhai Ahir both R/o.Silvassa (3) Chhanabhai Bablubhai Sahariya r/o.Kilwani (4) Ishwarbhai Kishanbhai Gavit R/o Khadoli were arrested on 09.04.2008 & (5) Dilipbhai Navjibhai Bhurkud R/o. Silvassa was arrested on 15.04.2008. After completing the investigation, case was chargesheeted vide No.67/08 dtd.22.04.2008 & RCC No. 50/08. The case is pending trial in the Court of law.
