The Ministry of Tribal Affairs vide letter No. 12026/5/2014-C&LM-I dated 01/01/2019 had forwarded the copy of the letter No. 9204/PCR(C)9/14/SSD dated 28/04/2018 of SC & ST Development Department, Govt. of Odisha alongwith letter No. 799/R-70/02 dated 06/04/2018 of the Director, Scheduled Castes and Scheduled Tribes Research and Training Institute, Govt. of Odisha, Bhubaneshwar contains the report and comments / justification for inclusion of "Uram/Oram, Uraon/ Dhangara and Oraon Mudi" communities as synonym of Oraon ST enlisted at Sl. No. 53 in the list of ST of Odisha State. A copy of the letter No. 8/1/2004-SS(Odisha) dated 12/11/2017 (2018) of Registrar General of India, New Delhi contains the comments for inclusion of the above communities also enclosed with the letter and requested the NCST for comments / views of the matter.

2. It may be observed that the Office of RGI in their letter No. 8/1/2004-SS(Odisha) dated 12/11/2017 (2018) has mentioned that "the RGI reiterates it supporting comments sent in the year 2006 for inclusion of Uraon as synonym of Oraon ST of Odisha. As regards other synonyms namely Uram/Oram/Dhangara and endogamous section Oraon Mudi, the Office of RGI is not in a position to offer any comment, since there is no reference on the said names either in earlier Census Reports or in ethnographic literature. These are Administrative issues and the Ministry may take its own view on the said matter.

3. The proposal of the State Govt. of Odisha and comments of the Office of the RGI on the proposal for inclusion of above communities in list of ST of Odisha was considered by the Commission. It was observed that the Director, Scheduled Castes and Scheduled Tribes Research and Training Institute, Govt. of Odisha, Bhubaneswar vide letter No. 799/R-70/02 dated 06/04/2018 had furnished the factual report and comments / justification for inclusion of "Uram/Oram, Uraon/Dhangara and Oraon Mudi" communities as synonyms of Oraon listed at Sl. No. 53 in the list of Scheduled Tribes of Odisha State.

4. After detailed discussion , the NCST concludes that the report and comments submitted by Director, Scheduled Castes and Scheduled Tribes Research and Training Institute, Govt. of Odisha, Bhubaneswar vide letter No. 799/R-70/02 dated 06/04/2018 for inclusion of "Uram/Oram, Uraon/ Dhangara and Oraon Mudi" communities as synonyms of Oraon listed at Sl. No. 53 in the list of Scheduled Tribes of Odisha appears to be in order. Accordingly, Commission supports the proposal of Ministry of Tribal Affairs for inclusion of above communities in list of Scheduled Tribes of Odisha State.
