A representation dated 30/05/2017 received from Shri Chandan Kumar regarding delaying of scholarship funds from Department of Social Welfare, Uttar Pradesh.

The matter was taken up with the Vice-Chancellor, Uttar Pradesh Technical University, Lucknow, Principal Secretary, Social Welfare Department, Govt. of Uttar Pradesh and Chief Executive Director, Babu Banarasi Das, National Institute of Technology and Management, Lucknow, Uttar Pradesh vide this Commission's letter dated 01/03/2017, 20/06/2017 & 28/08/2017. No reply received from the above said authorities therefore, a sitting has been fixed by the Hon'ble Member, Shri H. C. Vasava on 04/10/2017 at 12:00 Noon for discussion in the matter but none was present in the sitting on the above date. Therefore, Shri H. C.
