

Representation dated 22/07/2017 received from Shri Rahul Kumar, R/o B-13/7, Janata Flats Sector-71, NOIDA, Gautambudhh Nagar - 201301 (student of Polytechnic Diploma of IIMT College of Polytechnic, Greater Noida, District – Gautam Budh Nagar (Uttar Pradesh) regarding release of scholarship fund.

The case was referred to the Principal Secretary, Social Welfare Department, Govt. of Uttar Pradesh, Lucknow vide the NCST's letter dated 28/08/2017, 26/09/2017, 13/11/2017 and 11/04/2018 for furnishing the facts and comments in the matter. The response was not received. The Hon'ble Member fixed the sitting on 08/06/2018 with the Principal Secretary, Social Welfare Department, Govt. of Uttar Pradesh and the petitioner to resolve the issue.


In response to sitting notice, the Secretary, Social Welfare Department, Govt. of Uttar Pradesh vide letter No. 1823/26-3-2018 dated 06/06/2018 informed the NCST that the Principal Secretary, Social Welfare Department is on Training Leave on the day of sitting and requested for fixing another date in the month of July to discuss the issue. A copy of this letter was endorsed to District Social Welfare Officer, District Gautam Budha Nagar for appearing before the Commission personally on 08/06/2018 and present the facts in the matter. In the sitting, District Social Welfare Officer and the petitioner were present.

The Hon'ble Member asked the petitioner to explain his grievance. The petitioner explained that the scholarship for the year 2013-14 and 2014-15 had not been sanctioned by the Social Welfare Department so far. He faced difficulties to complete the Diploma. Now the Polytechnic College is not issuing Diploma certificate due to non-payment of amount by him. The Hon'ble Member asked the District Social Welfare Officer to explain the action taken by
