Proceeding of the sitting held on 22.05.2018 before Smt Maya Chintamn Ivnate, Hon'ble Member, NCST in the matter of representation of Shri K.Narayana Rao, Forum for Social Justice, ,Amravati, Distt. Guntur regarding various grievances of Schedule Tribes of Mahatma Jyotiba Phule Colony, Tanali Municipality, District Guntur.

Sitting held: 22.05.2018

- 1. During the sitting, the petitioner Shri K. Narayana Rao has submitted the grievances of non-issuance of house pattas and pakka house to the ST people. It was informed to the Commission that the resident of Mahatma Jyotiba Phule Colony, near Guravaiah Colony, Tenali, Guntur, who belongs to ST, SC, BC, OBC & Muslim minorities do not have minimum facilities like drainage water, approach roads etc. to their colony, which was a government site occupied by them very long back. 04 Scheduled Tribe families have been evicted by the Tenali Municipality from their houses. In addition, the District Administration has not issued pattas and pakka houses to them.
- 2. The District Collector Guntur and the Commissioner, Tenali Municipality have appeared and submitted a written report to the Commission. The District Collector Guntur informed the facts of case that the land an extent of Ac. 17.35 Cents where the ST persons are living is Govt. land and belonged to Tanali Municipality. The petitioners have illegally occupied the land and there is mixed population of SCs, STs, BC, OBC & Muslim minorities. The land was acquired by the Tanali Municipality for Sewerage Treatment Plant and is being used as Sewerage Treatment Plant. No persons have been evicted from their houses so far. However, under the Central Scheme of 'Housing for all', the State Govt. has decided to construct Pakka house for the families living in the said land on subsidy and contributory basis. In this regard the Govt. has planned to construct 1250 Pakka houses. Accordingly, a list of beneficiaries has been prepared and the petitioner's names are also in the list. The petitioners will be given

Smt. Maya Chintamn Ivnate Member Istional Commission for Scheduled Tribas Govt. of India, New Dalhi constructed house with all basic facilities. The houses will be constructed within one-year period and no persons living in the land will be evicted.

- 3. The case discussed in detail. The Commission recommends that District Collector and Tenali Municipality authorities may ensure that no Schedule Tribe persons/families will be evicted from their houses till the handover possession of the constructed house. All basic facilities may be provided to the Colony. The petitioner may be allotted pakka houses within one-year period as assured by District Collector during the sitting. It may also be ensured that the loans and subsidy for the pakka houses will be made available to the Schedule Tribe families for the houses.
- 4. An action taken report may be submitted to the Commission within 30days. After receipt of the action taken report, the case may be treated as closed.
