

PROCEEDINGS OF SITTING HELD ON 18.07.2018 AT 02.00 P.M. CHAIRED BY SMT. MAYA CHINTAMNIVNATE, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF OF SHRI AMOL, S/O SHRI DULAJI BHOJANE, 3/2, CHAVAN BHOSALE CHOWL, BHATWADI, GHATKOPAR WEST, MUMBAI (MAHARASHTRA) REGARDING AUTHENTICATE CASTE CERTIFICATE OF CANDIDATES APPOINTED IN SBI UNDER ST CATEGORY.

The National Commission for Scheduled Tribes received a representation dated nil from Shri Amol Bhojane, S/o Shri Dulaji Bhojane, 3/2, Chavan Bhosale Chowl, Bhatwadi, Ghatkopar West, Mumbai (Maharashtra) regarding caste certificate of candidate appointed in SBI under ST category. He has submitted the following:

- a. There was one ST vacancy for the post of Tester (MMGS-II) in SBI. He along with one another ST candidate appeared for personal interview for the said post on 07.03.2017. At the time of document verification, he has submitted all requisite documents along with caste certificate to the SBI Management. However, another ST candidate did not submit caste certificate.
- b. The SBI selected another ST candidate despite non submission of ST certificate and the SBI Management has issued appointment letter to him.
- c. He sought information through RTI about the selection of another ST candidate and also sought validity of ST caste certificate of the selected candidate.
- d. The SBI Management did not provide all information including ST caste certificate of the selected candidates.
- e. It was clearly mentioned in the advertisement that "caste certificate issued by the Competent Authority on format prescribed by the Government of India will have to be submitted by the SC/ST candidates, if called for interview". In spite of it SBI took undertaking from him at the time of interview and allow him to take interview. SBI is yet to verify the caste certificate of the candidate. It has been more than 9 months and caste certificate verification is still pending from SBI.

2. The NCST vide its letter dated 18.05.2018 sought report from the SBI. Thereafter, the SBI vide its letter dated 05.05.2016 has submitted a report intimating that the selected ST candidate has submitted his caste certificate at the time of joining in the Bank on 10.07.2017. As per existing instructions of the Bank the caste certificate of the selected ST candidates was sent to the District Magistrate, Muzaffarpur, Bihar on 07.10.2017. However, verification report is still awaited. A reminder was also issued on 17.02.2018.

3. As the report was found unsatisfactory, therefore, the Hon'ble Member (Smt. Maya Chintamn Ivnate) has fixed a Sitting on 18.07.2018 in the Commission. Accordingly, the General Manager, SBI and the petitioner concerned appeared.
4. During the Sitting the petitioner informed the Commission that the selected candidate does not belong to ST category as he has not submitted his caste certificate at the time of interview. In addition, after passing of more than one year, the Bank authority has failed to authenticate the ST caste certificate of selected candidates. The Bank has also not provided the ST caste certificate and other details of the selected candidates. No waiting list has also prepared by the Bank, in case the ST caste certificate of the selected candidates found to be fake. He is at Sl. No. 2 in the merit list after the selected candidate.
5. The SBI was stated that at the time of interview, the Bank has taken an undertaking to submit caste certificate at the time of joining. Accordingly, on selection, the selected ST candidate has submitted his caste certificate at the time of joining in the Bank on 10.07.2017. As per existing instructions, the caste certificate of the selected ST candidates was sent for verification to the caste certificate issuing authority i.e. District Magistrate, Muzaffarpur on 07.10.2017. However, verification report is awaited. The Bank has also issued reminders. A Senior Officer from the Bank side has also designated to expedite the matter. No waiting list has been prepared as there is no provision in the Bank.
6. The case was discussed in detail. The Commission has observed that after passing of about one year, the Bank has failed to verify the ST caste certificate of selected candidate. In addition, the Bank has not prepared a waiting list, in case ST caste certificate of the selected candidate is found to be fake.
7. The Commission therefore, recommends that the Bank should expedite the matter relating to caste verification of selected ST candidate with the concerned District Administration by deputing one Senior Officer from the Bank side. The Bank should form a waiting list for the post of Tester, so that the petitioner could get appointment in place of selected candidate, if the ST caste certificate of the selected candidate is found to be fake. The penalty proceedings and criminal proceedings against the selected ST candidate may also be initiated. A copy of minutes of this Sitting should be forwarded to District Magistrate, Muzaffarpur who is requested to expedite verification report in the instant case.
8. An action taken report should be submitted before the Commission within 30 days.
