Patel & others, R/o at Talodara, Taluk - Jhagadiya, District - Bharuch, Gujarat regarding exploitation and cheating of ST members of Shree Narmada sugarcane Industry Co-operative Ltd.



Representation dated 23/06/2017 received from Shri Ganpatbhai B. Patel & others, R/o at Talodara, Taluk - Jhagadiya, District - Bharuch, Gujarat regarding exploitation and cheating of ST members of Shree Narmada sugarcane Industry Co-operative Ltd.

This case was discussed in the sitting held on 13/10/2017 with District Registrar Co-operative Society, Narmada (Rajpipla) and In-charge Managing Director, Shree Narmada Khand Udyog, Sehkari Mandali Ltd. and the petitioner. In the sitting held on 13/10/2017, the Commission requested the District Registrar, Co-operative Societies to make available attested copy of the bye-laws of the Society urgently to the Commission. It was also decided by the Commission after examination bye-laws of the society the Commission will hold another sitting with all Stakeholder in the matter at the earliest. The minutes of the sitting was sent to all concerned on 08/11/2017. The action taken report was not received.

The Hon'ble Member, Shri HCV visited the State of Gujarat from 02/04/2018 to 04/04/2018. This case was discussed on 03/04/2018 with the concerned authorities again at Narmada District. In the tour report it was mentioned that "a report should be sent to the NCST within a month showing their findings as how the shares of non-STs have increased in the society and rights of STs were violated. The Commission also advised that if any violation of bye-laws of the society had been done, then the same should be rectified". Tour Report was sent to all concerned vide NCST letter No. BVV/2/2017/STGGJ/DELAAL/RU-I dated 24/04/2018 for furnishing the action taken report. The action taken report was not received.



The Hon'ble Member, Shri H. C. Vasava convened sitting on 07/06/2018 at 12:00 Noon in Lok Nayak Bhawan, New Delhi with the Chairman, Shree Narmada Khand Udyog, Sehkari Mandali Ltd., Deputy Registrar, Co-operative Societies, Rajpipla, Director of Sugar and the petitioner. In the sitting, Commission recommended / suggested that the facts / information presented in the sitting by the representative of Registrar, Co-operative Societies, Narmada and Director of Sugar should submit the action taken report in writing (in English or Hindi) within a month to the NCST from the receipt of the minutes of the sitting. After receipt of the facts, the NCST will decide further course of action. The minutes of the sitting was sent to the all concerned authorities vide NCST's letter of even No. dated 02/07/2018.

The action taken report on the recommendations made in the tour report of the Hon'ble Member from the concerned Department was not received. Hence, Hon'ble Member, Shri H. C. Vasava fixed the sitting on 30/07/2018 at 12:00 Hours at Circuit House, Gandhinagar to discuss the issue with the Registrar Cooperative Societies and Collector, District – Narmada. In the sitting Registrar, Cooperative Societies, Gujarat State, Gandhinagar, Joint Registrar (Sugar), Gujarat State Gandhinagar and petitioner were present.

In the sitting, the petitioner submitted representation dated 30/07/2018 (in Gujarati language) to the Hon'ble Member, Shri H. C. Vasava and the Joint Registrar (Sugar), Gujarat State, Gandhinagar and requested for justice. The Hon'ble Member asked the Officers to comment on the issue raised in the representation. Registrar, Cooperative Societies, Gujarat State, Gandhinagar and Joint Registrar (Sugar), Gujarat State, Gandhinagar told that issue raised in the representation dated 30/07/2018 of Shri Ganpatbhai B. Patel will be examined and comments thereon will be submitted to the Commission. In addition to this, recommendations of the Commission in its sitting dated 07/06/2018 is under examination., the comments / information on the suggestions / recommendations of the NCST will be sent to the Commission within 15 days.

After discussions, it was suggested / recommended that the documents / information on the issue raised in the representation dated 30/07/2018 of the petitioner and recommendations made in the tour report dated 02/04/2018 to 04/04/2018 of Shri H. C. Vasava to Gujarat State should be submitted by (in English or Hindi) the Registrar Cooperative Societies and Registrar (Sugar) Gujarat State within 15 days to NCST from the date of sitting. If there is any discrepancy / contradictory information, a Committee will be set up to re-examine the issue.
