Representation dated 16.10.2017 received from Shri Thangminlen Kipgen, President, Kuki Students Organization, Kangpokpi- District, Manipur regarding unlawful and forcible allotment of Tribal land in Manipur for the National Sports University. The same has been sent to the Chief Secretary, Government of Manipur vide this Commission's letter of even no. dated 03.03.2018 to furnish the comments/information to this Commission at the earliest. Despite reminder dated 12.06.2018, no information was received in the Commission from the concerned authority.

2. Shri H.K. Damor, Member, National Commission for Scheduled Tribes has fixed a Sitting in the Commission on **28.08.2018 at 11:30 A.M.** in the Commission's Conference Room, 6th Floor, 'B' Wing, Lok Nayak Bhawan, Khan Market, New Delhi for investigation/inquiry/action to be taken in the matter.

Gist of discussion/advice

Representatives of Kuki Students Organization of Manipur requested that revenue land records of the disputed land including survey report, lay out plan may be provided to them. It was also requested to confirm that the land in question identified for the sports University is not tribal land.

After detailed discussion on the subject, Shri Hari Krishna Damor, Hon'ble Member advised to the Secretary (Government of Manipur) to survey Haraothel village belongs to Saitu-Gamphazol Sub Division of Kangpokpi District and submit the survey report and records of land of this areas. Deputy Secretary (Revenue) Government of Manipur has requested one month time for providing the records of land and survey report to the Commission. Hon'ble Member agreed to this request and advised the Manipur Govt. to provide revenue land records of the disputed land including survey report, lay out plan and also confirm that the land for the sports University is not tribal land.
