
Minutes of sitting held in the Commission on 26/10/2018 at 11:30 A.M. ~~at 11:30 A.M.~~ under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Vinodbhai Luxibhai Lotda, Primary School, Karchond, Payaripada, Dudhani Centre, Dadra & Nagar Haveli regarding regularisation of Primary Teachers in Govt. School in Dadra & Nagar Haveli.

List of participants is annexed.

Representation dated 16/03/2018 received from Shri Vinodbhai Luxibhai Lotda, Primary School, Karchond, Payaripada, Dudhani Centre, Dadra & Nagar Haveli regarding regularisation of Primary Teachers in Govt. School in Dadra & Nagar Haveli. Representation was referred to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments within 30 days from receipt of the letter dated 11/04/2018. Response was not received.

Shri H. C. Vasava, Hon'ble Member, NCST discussed the issue with the AAO, Primary Education, Silvasa and the petitioner in the sitting held on 24/05/2018 and 28.08.2018. After discussions in the sitting held on 28.08.2018, the Hon'ble Member suggested / recommended that the case of ST candidates may be considered on the humanitarian and economic grounds, perhaps they have crossed the age limit, for natural justice. The TET and other conditions may also be waived for Scheduled Tribes candidates, those were appointed in 2006-07. The action taken report in the matter may be sent to the Commission within 15 days from receipt of the minutes of the sitting.

The proceedings of sitting dated 28.08.2018 was sent to Administrator, UT of Dadra & Nagar Haveli, Silvassa for furnishing the action taken report in the matter, vide letter dated 11.09.2018. A copy of the same endorsement to the CEO, District Panchayat, Primary Education, Silvassa. The action taken report was not received. The Hon'ble Member fixed the sitting on 26.10.2018 to discuss the issue with the Administrator, UT of Dadra & Nagar Haveli in the matter. Accordingly, NCST vide letter dated 15.10.2018 has issued the notice for sitting on 26.10.2018.

In response to sitting notice dated 15.10.2018, the Chief Executive Officer, (DP) Dadra Nagar Haveli, Silvassa vide letter No. EDN/EST/PST/Regular/2010/1324 dated 25.10.2018 has deputed the Shri G.A. Bhandari, Education Officer, Department of Primary Education, D& NH, Silvassa to attend the sitting on 26.10.2018. In the sitting dated 26.10.2018, petitioner was also present.

The Hon'ble Member asked the petitioner to explain the grievance. The petitioner informed that the Administration has not taken any action on the suggestions of Commission. The Hon'ble Member asked the Education Officer, D& NH, Silvassa to explain the action taken by the Department in the matter. The Education Officer, informed that the Department has initiated the action in the matter, which is under submission with Higher authorities.

The Hon'ble Member observed that the Dadra & Nagar Haveli, Administration not taken the action on the suggestions of sitting held on 28.08.2018 and also not furnish the report/ information to the Commission intime. It was also observed that the Administration deputed the officer in the sitting (s) who not empowered to take a decision. Hence, the next sitting in the matter should be fixed in the last week of November, 2018 and competent officer of D& NH, be asked to present in the sitting.
