Minutes of meeting held on 07/03/2019 at 1200 Hours onwards at Rajpipla (Guest House), District – Narmada, Gujarat under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Bhupatsingh Vitthalbhai Vasava, R/o Narendra Park Society, Plot No. 2 at Vadiya, Taluk – Nandod, District – Narmada, Gujarat regarding compensation of his land acquired by the Govt. of Gujarat for construction of Govt. Guest House.

2. Shri Bhupatsingh Vitthalbhai Vasava, R/o Narendra Park Society, Plot No. 2 at Vadiya, Taluk – Nandod, District – Narmada, Gujarat vide representation dated 14/06/2017 has requested to NCST for compensation to the acquired land for construction of Govt. Guest House. The NCST took up the matter with the Secretary, Road and Building Department, Govt. of Gujarat for facts and comments on 30/06/2017. Response was not received from the authority. Hence, NCST convened the sitting on 09/08/2017 to resolve the issue. The minutes of sittings was communicated to the Road and Building Department, Govt. of Gujarat for submitting action taken report.

3. Shri H. C. Vasava, Hon'ble Member, NCST alongwith Officials of NCST undertaken the visit from 02/04/2018 to 04/04/2018 to Gandhinagar, Narmada and Chhota Udaipur of Gujarat State. This case was also discussed during the visit with the Collector, District - Narmada and Secretary, Road and Building Department, Govt. of Gujarat. During the discussion, The Collector – Narmada reiterated that the market rate of land required will be provided to the original owners of the land. The Commission advised the Revenue Secretary, Govt. of Gujarat and Collector, Rajpipla to provide market rate of the land to the petitioner within two week's time. The tour report was sent to the Collector, District – Narmada and the Secretary, Revenue Department on 24/04/2018 with request that the action taken report on the recommendations of the Commission be sent urgently. Further, NCST fixed the sitting on 07/06/2018 to discuss the matter with the Secretary, Revenue Department and District Collector, Narmada and the petitioner. The sitting was postponed as none of the Officers from the District Narmada and Revenue Department, Govt. of Gujarat was present for 29/06/2018. On the sitting dated 29/06/2018 no one was present from the District Administration of Narmada and Revenue Department, Govt. of Gujarat. Accordingly, the Hon'ble Member has fixed the sitting for 30/07/2018 at Gandhinagar, Gujarat.

3. In the sitting held on 30/07/2018 at Circuit House, Gandhinagar, (Gujarat) under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST, after discussions, it was suggested that the point-wise information and action taken / to be taken by the District Administration, Narmada on the recommendations / suggestions of the tour report dated 02/04/2018 to 04/04/2018 of the Gujarat State, which includes this case should be sent to the NCST within 30 days from the date of sitting. After receipt of the Action Taken Report from the Collector, District Narmada as well Revenue Department, Govt. of Gujarat, further course of action will be decided by the Commission. The Minutes of sitting was sent to the District Collector, Narmada and Revenue Department, Govt. of Gujarat on 07/08/2018 with request to furnish the Action Taken Report to the NCST at the earliest.



4. The Action Taken Report on the recommendations of the sitting dated 30/07/2018 held at Gandhinagar under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST from the District Administration of Narmada and Revenue Department, Govt. of Gujarat was not received. Accordingly, Hon'ble Member, NCST decided to discuss the matter with the District Administration, Narmada on 07/03/2019 at Rajpipla (Gujarat). The communication for the meeting / sitting was sent to the District Administration and the petitioner.

5. In the meeting dated 07/03/2019 with the Collector, District – Narmada and other concerned Officer of District Administration, Narmada and the petitioner, the Hon'ble Member asked the petitioner to explain the present position of the case. The petitioner stated that the compensation has not been provided by the Administration. The Hon'ble Member asked the Collector, Narmada to explain the action taken by the District Administration in the matter. The District Collector assured that the action will be taken by the District Administration for providing the compensation as per market rate. The Commission suggested that it will be duty of District Administration to process his case for settlement / providing compensation at the earliest. The petitioner, if he feels any difficulty, he may approach / meet the Collector / Deputy Collector in this aspect.

6. Meeting ended with the vote of thanks to the chair.
