

The full facts, action taken report and other relevant original records/documents pertaining to the case will also be examined by the NCST team.
4. Accordingly, all concerned authorities are requested to remain present at the time of inquiry on the scheduled date and time at the designated venue with all relevant records.
5. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.




