Minutes of sitting held in the NCST's Headquarters on 12/07/2019 at 12:30 PM under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST in the case of Shri Vedkumar Dhanka, 74A G/F Gali No. 5 Thansingh Nagar Anand Parvat New Delhi regarding non installation of new electric meter by BSES Yamuna Power Ltd, Patel Nagar.

Shri Ved kumar Dhanka S/o Shri Ram Kumar Dhanka, 74A G/F Gali No. 5 Thansingh Nagar Anand Parvat, New Delhi, vide representation dated 06.06.2019 had stated that BSES Yamuna Power Ltd, Patel Nagar not installing electric meter in his house and requested for directions to resolve the issue. The Hon'ble Chairperson, NCST fixed the sitting on 12.07.2019 at 12.30 PM to discuss the issue with Secretary, Department of Power, GNCTD and officers of BSES, Yamuna Power Ltd and the petitioner to resolve the issue. Accordingly, the sitting notice was issued on 25.06.2019 and 03.07.2019.

Secretary, Department of Power, GNCTD vide letter No. F. 11(90)/2016/Power/Admn/Misc/1847 dated 12.07.2019 had deputed Deputy Director, Power to attend the sitting and the Chief Executive Officer, BSES Yamuna Power Ltd had deputed Deputy General Manager (Legal) to attend the sitting on 12.07.2019. The petitioner was present in the sitting.

The Hon'ble Chairperson asked the petitioner to explain the problems. The petitioner informed that the BSES, Patel Nagar not installing the electric meter after the directions of the Hon'ble Court. The Hon'ble Chairperson asked the representative of BSES to explain the action taken by their department in the matter. The representative of BSES apprised that a meter was installed in the name of Smt Kaushalya Devi in the same house, which was removed. Now the petitioner is demanding for new connection.

Commission observed that installation of more electric meter will be beneficial for the BSES. The installation of new electric meter in favour of petitioner and other party at the same house will be appropriate action on the part of BSES, Yamuna Power Ltd, as per the scheme of "Pradhan Mantri Sahaj Bijli Har Ghar Yojna".

After detailed discussions with the representative of BSES, Yamuna Power Ltd, representative of Department of Power, GNCTD and the petitioner, Commission recommends that BSES should installed electric meter in the name of the petitioner at his house. Report on the action taken/ to be taken by BSES, Yamuna Power Ltd in the matter may be submitted to the Commission within 15 days from receipt of the proceedings of the sitting.
