Minutes of sitting held in the NCST's Headquarters on 15/07/2019 at 04:00 PM under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST in the case of Shri Y. Hari Babu, Door No. 20-8/1/14, Ayodya Nagar, Vijayawada-520003 regarding misutilisation of official powers by Shri M. B. Muralidhar/Dy.CPO/IR&RES/SC.

Shri Y. Hari Babu, (Door No. 20-8/1/14, Ayodya Nagar, Vijayawada), Ex- Additional Divisional Secretary, All India SC/ST Railway Employees Association, South Central Railway, Vijaywada Division, Krishna District, (Andhra Pradesh) vide representation dated 17.06.2017 has stated about misutilisation of official powers by Shri M. B. Muralidhar/Dy.CPO/IR&RES/SC and requested for justice. The NCST took up the matter with Chairman, Railway Board on 13.12.2017 for facts and comments. The Railway Board vide their OM No. 2018-E(SCT)1/74/1 dated 23.03.2018 had furnished the report of South Central Railway, which was referred by the Commission on 14.07.2018 to the petitioner for satisfaction. The petitioner was not satisfied with the reply. Accordingly, Hon'ble Chairperson fixed the sitting on 15.07.2019 at 04.00 PM to discuss the issue with the Chairman, Railway Board and the petitioner.

The Chairman, Railway Board vide D.O. No. 2016-E(SCT)II/2/21 dated 10.07.2019 has deputed PCPO/ SCR to attend the sitting. In the sitting on 15.07.2019, PCPO/SCR and SPO/ Res/SCR were appeared. The petitioner was not present.

The Hon'ble Chairperson asked the representative of South Central Railway to explain the action taken by their Department in the matter. The representative of South Central Railway provided a copy of the letter No. SCR/P-Hq/630/RP/SCT/Vol.12 dated 10.07.2019 of SCR along with letter dated 03.07.2019 of the petitioner addressed to Hon'ble Chairperson, NCST. In the letter dated 03.07.2019 of the petitioner, it had been mentioned that the "S.C. Rly, Zonal Body said to be announcing elections in the next month. My contention is also the same. So I think there is no necessity for furtherance this case. I therefore, requesting your good-self to close this case at an early date. The representative of Railway informed that the petitioner has filed a closure petition dated 03.07.2019, before the Hon'ble NCST. Hence, this case may be closed.

After discussions with the representative of SCR, Commission decided to close the case.
