
**Minutes of sitting held in the NCST's Headquarters on 08/08/2019 at 12:00 Noon under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Ramjibhai Chaitabhai Dheendha, Silvassa, UT of Dadra & Nagar Haveli regarding grabbing of his land and non-payment of sale amount.**

List of participants is annexed.

Shri Ramjibhai Chaitabhai Dheendha, Village- Sayli, Dheendha Pada, Silvassa (UT of Dadra & Nagar Haveli) vide representation dated 10.04.2019 has stated that his land has been encroached by M/s Wellpack Industries Pvt. Ltd and sale amount of his land not paid by Shri Mohanbhai S. Delkar and requested for justice. The NCST referred the matter to Administrator, UT of D & NH for facts and comments vide letter dated 11.04.2019. Response was not received. Hence, the Hon'ble Member NCST fixed the sitting on 08.08.2019 to discuss the issue with the Administrator, UT of D & NH and the petitioner to resolve the issue.

In the sitting on 08.08.2019 the Resident Deputy Collector (s), Silvassa appeared from the UT of D& NH Administration. The petitioner was present in the sitting. The Hon'ble Member asked the petitioner to explain the grievance and problems. The petitioner informed that Shri M.S. Delkar had forcefully taken his signature on the related papers and promised for giving an amount of Rupees three lakhs forty- five thousand, as per Sale Deed. But, till date nothing had been paid to him by Shri M.S. Delkar. The M/s Wellpack Industries Pvt. Ltd had encroached his land bearing survey No. 192/1 of Village Sayli.

The Hon'ble Member asked the Resident Deputy Collector (s) to explain the facts and action taken by the Administration. The Resident Deputy Collector (s), Silvassa stated that the facts and information had already been submitted to the Commission vide letter No. RD/RTS-I/NCST/RCD/2019/116 dated 07.08.2019. It was informed that the land bearing survey No. 192/1 admeasuring 0-39 Hectare of Village Sayli is currently under the ownership and possession of the petitioner. The petitioner grown/ cultivated rice crop on the said land. In respect of non- payment of amount to the petitioner by Shri M.S. Delkar for land bearing survey No. 169/P2 admeasuring 0-69 Hectare of Village Sayli, it was informed that the said land is currently under the ownership



of Shri Mohanbhai S. Delkar. The petitioner sold this land to Shri M.S. Delkar with sale permission of Collector, D & NH dated 30.07.2002. The said sale was mutated in the revenue record in January, 2003. The Administration is not aware about the non- payment of amount of Rupees three lakhs forty- five thousand to petitioner by Shri M.S. Delkar.

The Resident Deputy Collector (S), Silvassa suggested that he/ other employee will visit the land bearing survey No. 192/1 of Village Sayli for clear demarcation of land which is ownership of the petitioner within 15 days.

After discussions with the Resident Deputy Collector (S), Silvassa, petitioner and the other representative from Silvassa, the Hon'ble Member recommended that a representative from Revenue Department, District- Silvassa should visit the said area and demarcate the area of land bearing survey No. 192/1 admeasuring 0-39 Hectare of Village Sayli to the petitioner within 15 days. The matter for non- payment of Rupees three lakhs forty- five thousand to the petitioner by Shri M.S. Delkar may also be enquired by the Administration. Action taken report may be submitted to the Commission within a month from receipt of the proceedings of the sitting.
