MINUTES OF SITTING HELD IN THE NCST'S HEADQUARTERS ON 19/11/2019 AT 01:00 PM UNDER THE CHAIRMANSHIP OF SHRI H.C. VASAVA, HON'BLE MEMBER, NCST IN THE CASE OF SHRI SURESHBHAI NAGINBHAI PATEL, NEAR AYAPPYA MANDIR, SILVASSA, (DADRA & NAGAR HAVELI) REGARDING GRABBING OF HIS LAND BY EX-MP AND HIS BROTHER THROUGH CHEATING.



Shri Sureshbhai Naginbhai Patel, Near Ayappya Mandir, Silvassa, (Dadra & Nagar Haveli) vide representation dated 26.3.2018 has stated that the land bearing Survey No. 262/2 of Silvassagrabbied by Shri Natubhai Patel (Ex-MP) through cheating and requested for justice. The matter was referred to Administrator, UT of Dadra & Nagar Haveli and District Collector, Silvassa for facts and comments by the NCST on 26.4.2019. These agencies had been reminded on 12.6.2019 and 13.8.2019. The comments were not received from these agencies. However, the Mamlatdar (s), D&NH, Silvassa vide notice No. RD/NCST/SNP/2019/4280 dated 17.9.2019 (which was addressed to Shri Sureshbhai Naginbhai Patel and M/s Yogi Developers Silvassa) has intimated that the hearing in the matter fixed by the Collector, D&NH on 20.9.2019 at 5:30 PM. Further, no response was received from the Revenue Department, District D&NH, Silvassa.

A sitting was convened on 30.10.2019 at 01:00 PM to discuss the issue with the concerned officers and petitioner to resolve the issue. In the sitting, none of the officials from Administrator, Dadra & Nagar Haveli and District Collector were appeared in the sitting. The petitioner were present. In the sitting dated 30.10.2019, after discussion with petitioner and in view of the letter of Resident Dy. Collector (s) D&NH, Silvassa dated 29.10.2019, the Hon'ble Member decided to cancel the sitting and fixed the next dated of sitting for 19.11.2019.

As per decision taken in the sitting on 30.10.2019, sitting was fixed for 19.11.2019. Accordingly, sitting notice was issued on 07.11.2019 to Administrator, UT of D&NH and District Collector D&NH, Silvassa and petitioner. The Collector, D&NH vide letter No. ADM/Coll/Misc/2019/89 dated 18.11.2019 had deputed Mamlatdar, Silvassa to attend the sitting. The Collector D&NH has also furnished the facts vide letter No. RD/NCST-Corres/SNP/2019/90 dated 18.11.2019. A copy of this letter endorsed to PS to Administrator, D&NH and petitioner, Shri Sureshbhai Naginbhai Patel. The petitioner was also present in the sitting.


The Hon'ble Member asked the petitioner to explain the grievance and problems. The petitioner stated that the land bearing Survey No. 262/2 of Silvassa grabbed by Shri Natubhai Patel (Ex-MP) through cheating and requested for justice. The Hon'ble Member asked the Mamlatdar, Silvassa to inform the NCST above the action taken by the Administration. The Mamlatdar reiterated the facts submitted by District Collector Silvassa vide letter No. RD/NCST-Corres/SNP/2019/90 dated 18.11.2019. In this letter, it has been mentioned that the petitioner have to approach the Civil Court and competent authority in the land matters.
