MINUTES OF SITTING HELD IN THE NCST'S HEADQUARTERS ON 19/11/2019 AT 01:30 PM UNDER THE CHAIRMANSHIP OF SHRI H.C. VASAVA, HON'BLE MEMBER, NCST IN THE CASE OF SHRI KAMLESH MEENA (S/O SHRI GANESH NARAYAN, VILLAGE & POST- KACHAULIA, TEHSIL- BASSI, DISTRICT- JAIPUR, (RAJASTHAN) REGARDING CANCELLATION OF HIS CANDIDATURE BY THE RAILWAY RECRUITMENT CELL, NORTHERN RAILWAY, NEW DELHI MENTIONING ABSENT FROM MEDICAL EXAMINATION

Shri Kamlesh Meena vide representation dated Nil has stated that the Northern Railway has cancelled his candidature mentioning absent from Medical examination. The matter was referred to General Manager, Northern Railway, Baroda House, New Delhi, Divisional Railway Manager, Firozpur Division, Northern Railway, Firozpur and Chairman, Railway Recruitment Cell, Northern Railway for facts and comments on 09.8.2019. The General Manager, Northern Railway vide letter dated 30.8.2019 has informed that "on the receipt of absconding information from the Medical authority vide Memo No. 397703 dated 01.5.2019, status was updated on the Railway Recruitment Cell website for information of the candidate. This fact was communicated to petitioner on 10.10.2019. The petitioner was rejoinder dated 11.10.2019 has refuted the facts.

Accordingly, the Hon'ble Member has decided to discuss the matter with concerned authority of Railway and petitioner on 19.11.2019 to resolve the issue. The sitting notice was issued on 07.11.2019 to General Manager, Northern Railway, Baroda House, New Delhi, Divisional Railway Manager, Firozpur Division, Northern Railway, Firozpur and Chairman, Railway Recruitment Cell, Northern Railway, New Delhi and the petitioner.

The General Manager, Northern Railway vide letter No. 220-E/1258/12-NCST/FZR/19/RP Cell dated 01.11.2019 has forwarded the copy of the letter No. 54-Med/1/FZR dated 04.9.2019 of Sr. D.M.O./ Ortho/FZR dated 04.9.2019 addressed to Sr. Divisional Personnel officer, Firozpur. In this letter, it has been mentioned that "Shri Kamlesh Meena reported on 26.4.2019 for Medical examination in Medical category A-2 and below. He himself made his report of distant vision as 6/9 both eyes, wrote himself on examination slip, which is attached for reference".


General Manager, Northern Railway vide letter No. 220-E/1258/12-NCST/FZR/19/RP Cell dated 14.11.2019 intimated that matter pertains to Divisional Railway Manager, Northern Railway Firozpur. Hence, DRM, Firozpur is being deputed to attend the hearing and requested for dispensation for personal appearance. In the sitting, the DRM, Firozpur, Chairman, Railway Recruitment Cell, Northern Railway and SPO, Northern Railway appeared before the Hon'ble Member. The petitioner was also present.

The Hon'ble Member asked the petitioner to explain the grievance and problems. The petitioner reiterated his statement given in the representation and requested for justice. The Hon'ble Member asked the DRM, Firozpur to explain the action taken by them. The DRM, Firozpur reiterated the comments/facts given by General Manager, Northern Railway vide letter dated 01.11.2019 and stated that the petitioner makes forgery. Accordingly, action has been taken. This view was supported by Chairman, Railway Recruitment Cell and also shown the letter for absent for Medical examination. It was also informed that the Railway authority has appointed/selected the candidate for the said post from the panel list.

The Hon'ble Member observed that the petitioner himself agreed that he has put the remarks for eye test which has been mentioned in the documents provided by the Railway authority. This reveals forgery.

After discussions, the Hon'ble Member observed that there is no role of NCST in this matter. Hence, decided that this matter may be closed.
