After welcoming the participants and their introduction, the petitioner was asked to 2. 'explain his grievance.

The representative of the petitioner explained the matter in detail and apprised the Hon'ble Member that the Higher Education Department of Government of Andhra Pradesh has no issued orders for relieving the 22 SC/ST lecturers despite the fact that Govt of A P has accepted the same in principle. He requested the Commission to direct the Concerned Department of A P Govt. to issue the orders immediately.

The representative of the Government of A. P. apprised the Hon'ble Member that matter is under process of the Concerned department.

Hon'ble Member took note of the reply given by the representative of the Government of 5. A. P. and asked the Govt. of A. P. to expedite the issue of orders to avoid further harassment of the said 22 SC/ST lecturers and apprise the Commission of the action taken in the matter within 15 days.
