- 2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
- The petitioner submitted the grievances regarding illegally transfer of his agricultural land to non ST by the Revenue officials at Paddmadur Village, Devurupulla Mandal, Jangaon District, Telangana. He alleged that in the year 1984, one non ST namely Shri Akavaram Gopal Reddy had sold the land measuring 1 acre 31 Gts at Sy. No. 368B to the petitioner's namely Shri Banoth Somulu and his family members. Thereafter, the said land was again sold by family members of Shri Akavaram Gopal Reddy to third party without their knowledge and taking money of the land from them. When he objected and asked for money and land, the non ST person (Shri Reddy family) showed him a piece of land at sy. No. 410 and 411, which was a barren land and not fit for cultivation. Thus, the Reddy family have cheated with him. It is mentioned here that Shri Akavaram Gopal Reddy has passed away and now his son Shri Ram Narsimha Reddy is also planning to sell lands in sy. No. 410 and 411 measuring to the extent of acre 3.22 Gts which are recorded in the name of Shri Akavaram Gopal Reddy and inherited to his son. The petitioner requested to look into the matter and check if any property or land in the name of his son and take necessary action.
 - 4. The officer appeared before the Commission referred a report of District Collector, Jalgaon and stated that the petitioner had purchased

But the enjoyment land survey reveals that he is in possession of the land in Sy. No. 369 without any sale document and registered sale deeds. The petitioner does not have any valid land document. On other hand the son of Shri Akavaram Gopal Reddy was stated that his father was expired in the year 2010 and he is not aware of any sale transactions between his father and the petitioner in connection with lands in sy. No. 368/B. In addition, he is in enjoyment and possession of lands in sy. No. 411. Thus, the petitioner's allegations could not be proved true.

5. The Commission was not satisfied by the information given by the Officer and decided to hear that District Collector in its next sitting.
