A representation dt.13.09.2019 was Received from Dr.Koduri Narayana Rao National President, Forum for Social Justice, Guntur, Amarvathi, Andhra Pradesh Regarding Harassment of ST officials in Inter State Transfer of Lecturers working in Government Polytechnics on mutual grounds the NCST has issued notices to The Chief Secretary Government of Andhra Pradesh, Principal Secretary Higher Education Department Govt. of AP and Principal Secretary Skill Development Department Govt. of AP vide letter No.KNR/3/2019/STGAP/SCHRMT/RI-IV, Non Compliance of the issue the NCST conducted sitting under the Chairmanship of Smt Maya Chintamn Ivnate Hon'ble Member NCST on 03-12-2019 at 0300 PM at Commission Conference hall New Delhi to but the concerned officers were not present however on behalf of the Andhra Pradesh State Government Smt Bhavana Saxena IAS the Resident Commissioner IN Delhi, Govt of AP Were Attended the sitting & Petitioners also attended during the sitting. After detailed discussions with the officers of the state government of Andhra Pradesh Hon'ble NCST Issued Proceedings.

Further non attendance of the concerned officials of the previous Sitting Dr Nand Kumar Sai Hon'ble Chairperson, National Commission For Scheduled Tribes(NCST) decided to conduct a sitting an official tour program, Andhra Pradesh ,Scheduled on 26-12-2019 at with The Chief Secretary Government of Andhra Pradesh, Principal Secretary Higher Education Department Govt. of AP and Principal Secretary Skill Development Department Govt. of AP.

Due to Andhra Pradesh Cabinet Meeting On behalf of Chief Secretary, Principal Secretary Skill Development Department Govt. of AP The Special Commissioner of Technical Education, Andhra Pradesh state, The Deputy Secretary to Government, Higher Education Department, The Joint Director of Technical Education and The Assistant Director of Technical Education, Govt of AP, are Attended the Sitting and Petitioners also attended during the sitting.

In the Sitting The Petitioner has apprised that the presently there were working as a lectures in Govt. Polytechnics of Andhra Pradesh State. They are belonging to Telangana State (Nativity) and applied for interstate transfers from Andhra Pradesh State to Telangana State on mutual grounds as per the circular Memo No. 9940/SPF & MC/2015, Dt.07/08/2015.(on Different Subjects) based on their nativity, The Special Chief Secretary, Higher Education, Government of Andhra Pradesh vide Letter No. 4431.A1/2017., Dt.17.04.2018 have issued NOC for transfer of 45 individual (i.e.,6 No.s Spouse Grounds, 16 No.s of mutual grounds of same subject, 23 No.s of mutual grounds of different subject out of which 3 lectures belongs to ST Community Viz; at S.No. 2 Smt M.Radhika, at S.No.5 Smt Ade Savitha and S.No.6 Sri V.Veerana) of Government Employees between the State of Andhra Pradesh and the State of Telangana.

Further the Petitioner Dr.Koduri Narayana Rao has apprised that, only 22 Lectures (i.e.,6 No.s Spouse Grounds, 16 No.s of mutual grounds of same subject) have got interstate transferred from A.P to T.S (Vise versa) and the remaining 23 individual (i.e., 23 No.s of

mutual grounds of different subject) had pending the file No. vide reference File No.4431/TE. A2/2017, Dt.17.04.2018 from Spl. Chief Secretary, Government of Andhra Pradesh


Further the petitioner has stated that the Government of Telangana vide Higher Education (TE) Dept., G.O M.S No. 48 Dt. 29.12.2019 have issued G.O for the remaining 23 lecturers (i.e., 23 No.s of mutual grounds of different subject) seeking interstate transfer on mutual grounds and The Spl Chief Secretary, Higher Education (TE)Dept. Government of Telangana have also issued NOC vide,LetterNo.6284/TE/A1/2017., Dt. 29.12.2018 for acceptance of employees from Andhra Pradesh State.

Further the petitioners has stated that it has come to the notice that only 14 members of Lecturers out of 23 members are accepting to relieve from the state of Andhra Pradesh to State of Telangana. The petitioner has humbly requested that remaining members of lecturers also shall be considered for Inter-state Transfers from Andhra Pradesh State to Telangana State,

Further, the petitioners apprised to the Hon'ble Chairman, National Commission for Scheduled Tribes to consider on sympathetically grounds to Inter-state Transfers and recommend to the Special Chief Secretary, Higher Education Department of Andhra Pradesh and Secretary Skill Development Department Govt. of AP for considering explicit 3 lectures belongs to ST Community Viz; at S.No. 2 Smt M.Radhika, at S.No.5 Smt Ade Savitha and S.No.6 Sri V.Veerana for Interstate Transfers from Andhra Pradesh State to Telangana State, as the permission accorded by the Telangana State Government vide G.O M.S No. 48 Dt. 29.12.2019.

After detailed discussions with the officers of the state government of Andhra Pradesh and petitioner The Hon'ble Commission recommends that The both Governments have agreed and issued Orders for Interstate Transfers of Lecturers working in Government polytechnics (Technical Education) Andhra State to Telangana State The Skill Development Department Govt. of AP, The lecturers of polytechnic college Should be Transferred (Inter-state) to Telangana as per the G.O M.S No. 48 Dt. 29.12.2019 issued by Higher Education (TE) Department Government of Telangana have also issued NOC vide,LetterNo.6284/TE/A1/2017., Dt. 29.12.2018 for acceptance of employees from Andhra Pradesh State. and The Skill Development Department Govt. of AP. The Cases of above lecturers Should be considered as a Special Case on Priority basis.

Action taken report on the recommendations of the Commission should be furnished by The Skill Development Department Govt. of AP to the Commission within 15 days positively.
