**Minutes of the Sitting held on 07.10.2021 at 11.00 A.M. under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, New Delhi on representation of Shri Biswanath Oram, Jalda B Block, P.O- Jalda, PS- Raghunathpali, Sundargarh, Odisha regarding restoration of land bearing Sabik Khata No. 110 of Mouza - Mahulpali as per direction of court of O.S.D (LR) Panposh.**

In this matter, as per direction of Hon'ble Member SUMMONS dated 30.09.2021 were issued to the District Collector, Sundargarh, Odisha.

In this matter, previous sitting was held on 18.10.2021 and action taken report dated 14.01.2020 was received from office of the District Collector wherein it was stated that the matter is Sub-Judice in the Court of Addl. District Magistrate. Shri AnantaNayak, Hon'ble Member, NCST, fixed a Sitting on 07.10.2021 at 11.00AM in the Commission (HQ), New Delhi to discuss in the matter with the above said authority.

During the sitting, the petitioner demanded as under :-

The land to be returned to him as Sabik Khata No. - 110 of Mahulpali, Panposh. In earlier sitting, the Dist. Collector admitted that administration will hand over that land to him but till now the said land has not been restored.

The Collector, Sundargarh agreed that the administration will return the 2.15 ~~Acres~~ undisputed land out of 7.74 ~~Acres~~ land to BiswanathOram within 2 months.

**After hearing both the parties, the Commission recommends that:**

- The District Administration should take appropriate to return the 2.15 Acres land in favour of Shri Biswanath Oram.
- The competent Revenue Court may decide Case No. 26/2018 at the earliest.

An action taken reply on the above recommendation be sent to NCST within a period of 30 days.
