Sub: Proceedings of the sitting, ^{held} under the Chairmanship of Hon'ble Vice Chairman in the case of Shri Mehar Chand, P.O. Tindi, Sub Tehsil Udaipur, District Lahaul Spiti held in the NCST.

1. The meeting, under the Chairmanship of Hon'ble Vice Chairman, NCST, to discuss the case of Shri Mehar Chand, took place in the Conference Room, NCST at 4:00 PM on 21/10/2016.
2. The list of participants in the meeting is given at Annexure A.
3. The petitioner was asked to present his case. The petitioner wanted to know the outcome of interview for the post of Assistant Librarian held on 14.1.2003 in the District Library Keylong, Govt. College Kukumseri and Government School in District Lahaul Spiti. The petitioner appeared for the interview and for the total posts of 14, his rank was 7, but nothing is known about the result of the interview till today.
4. Shri Satish Chandra Sharma, Joint Director (Higher Education), Himachal Pradesh has represented the status of the case on behalf of the Education Department of the Govt. of Himachal Pradesh. He also stated that information regarding result of 2003 interview and the process of appointment during 2003 is not available with him.
5. The Hon'ble Vice Chairman, NCST took serious note of the matter and stated that.
 - a. Shri Mehar Chand is an ST (IRDP) and his candidature was not considered.
 - b. He already discussed this matter with Chief Secretary/Joint Secretary/Joint Director (Education) during his visit to Himachal Pradesh.
 - c. Education Department has neither cancelled the process of interview conducted in the year 2003 nor declared the result.

- e. Shri Mehar Chand wasted time, energy & money in the hope that he will get the appointment in the Himachal Government.
6. Considering the entire aspects of the case, the Hon'ble Vice Chairperson has directed that Education Department should appoint him on Compassionate Ground.
