
Proceedings of the sitting taken by the Vice-Chairperson, National Commission for Scheduled Tribes (NCST) on 21-10-2016 at 3.00 P.M. in the matter of Shri G.S. Negi, Manager, MTNL, New Delhi regarding implementation of High Court Order dated 14.05.09 and request for promotion.

Date of sitting: 21.10.2016

Representations dated 21.01.2016, 08.03.2016 and September, 2016 were received from Shri G. S. Negi, Deputy General Manager (Legal), WS, MTNL, New Delhi regarding retrospective promotion and other benefits w.e.f 01.01.2015 in E-8 (non functional) and 01.01.2016 E-9 (non functional) due to non-implementation of observation/recommendation of Hon'ble Commission vide proceedings of the Sitting on 26.02.2014.

2. The Hon'ble Vice-Chairperson, NCST invited Chairman-cum-Managing Director (CMD) and other officers of MTNL for the comments on the issues raised by Shri G.S. Negi in the representations.
3. The CMD, MTNL explained the history of the case and described that Shri G.S. Negi is fighting promotion case from 1999 before the various authorities like High Court, Supreme Court and NCST.
4. The Hon'ble Vice-Chairperson, NCST asked the Shri G.S. Negi for explaining his case. Shri G.S. Negi again demanded for retrospective promotion and other benefits w.e.f 01.01.2015 in E-8 (non functional) and 01.01.2016 E-9 (non functional). The CMD, MTNL stated that Shri G.S. Negi is presenting different issues before various authorities. CMD, further


stated that, if Shri G.S. Negi is ready to give a statement in writing that he will not take up his issue (promotion matter) before any authorities. The MTNL will brought his issue before the Board to settle the case, immediately.

5. Shri G.S. Negi again raised his grievance for non - functional promotion in E-8 and E-9. CMD, MTNL again emphasized facts on the issues raised by Shri G.S. Negi and agreed for providing benefits as stated by Shri G.S. Negi and further promotion, if, Shri G.S. Negi give a statement in writing that he will not submit a proposal in this regard before any authorities in future. The case will be settled by the MTNL within two months.

6. The Hon'ble Vice-Chairperson advised Shri G.S. Negi to give a statement in writing, as stated by CMD, MTNL. So that MTNL may initiate action to resolve the issue.

7. As per advice of Hon'ble Vice-Chairperson, NCST, Shri G.S. Negi had given a statement in writing attached at **Annexure - II** and assured that he will not give any representation before any authorities in future.

8. It was decided that the MTNL will initiate action to settle the case of Shri G.S. Negi within two months from receipt of the proceedings of the Sitting and report to the Commission.
