

- In this matter, as per direction of Hon,ble Member (AN) Notice dated 26.04.2021 was issued to the Collector & District Magistrate, District-Angul and SUMMONS dated 10.12.2021 were issued to the Collector & District Magistrate, District-Angul.
- During the Sitting, the petitioner claimed that he belongs to tribal Community and he himself and his family members don't have any land in their names. He stated that his entire family stays on a particular piece of land for last many decades. He sought intervention of the Commission for ensuring him the Patta (record of Right) where he has been residing and is in possession of the land.
- Appearing for the Collector & District Magistrate, District-Angul, the local Tehsildar stated that the petitioner is not landless as he has ancestral property in other village. He also possesses other piece of land in Keonjhar District. However, as he along with his family has been staying on the above piece of land for last many decades. Since, the Collector has power to allot him 10 Decimals of land, he should be ensured with the Land rights for ten decimiles. He requested the NCST to recommend the District Collector to exercise his power for allotting 10 decimals of land as desired.
- After Hearing both the parties, the Commission recommends: -

The petitioner, who is in physical possession of a large portion of the land as stated, must be allotted 10 decimals of land from the said land by the District Collector, Angul within a period of one month of receipt of the recommendation.
