Minutes of sitting held in the NCST's Headquarters on 13/04/2022 at 10:30 AM under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes in the case of Ms. Poonam Madhuri Toppo and Shri Lokesh Kumar Meena, Male Nurse, G.B. Pant Hospital and others regarding injustice with Scheduled Tribes employees working in the Health and Family Welfare Department, GNCTD

List of participants is annexed.

Representation of Ms. Poonam Madhuri Toppo and Shri Lokesh Kumar Meena, Male Nurse, G.B.Pant Hospital, New Delhi regarding injustice towards Scheduled Tribes employees working in the Health and Family Welfare Department, GNCTD was received in the NCST. The issue was discussed in the sitting(s) held on 13.10.2017, 20.02.2018, 11.08.2018, 26.09.2018, 05.03.2019, 12.02.2020 and 15.12.2021 in NCST with the officers of Health and Family Welfare Department and other stakeholders and petitioners. The Hon'ble Member, NCST in the sitting held on 15.12.2021 at NCST recommended that "Process of promotion from the post of Nursing Officer to Sr. Nursing Officer will be completed by Health & Family Welfare Department, GNCTD within a two months from the date of sitting. The action taken/to be taken may be submitted to NCST before stipulated time. The process of promotion is not completed the next sitting at NCST will be held in February, 2022.

There was no response from Health & Family Welfare Department, GNCTD and petitioners approached the Commission for justice. Accordingly, the NCST has decided to discuss the issue on 13.04.2022 with the Principal Secretary, Health & Family Welfare Department, GNCTD and petitioners. On 13.04.2022, the Special Secretary Health & Family Welfare Department, GNCTD and other officers appeared before the Commission and petitioners were also present. The officers of Health & Family Welfare Department, GNCTD submitted their department's letter No. F.8(140)/Nursing /H&FW/2017/335 dated 07.04.2022. It was also informed that the process of promotion from the post of Nursing officer to Sr. Nursing Officer will be completed by 2nd week of May, 2022 positively.
