PROCEEDINGS OF HEARING HELD ON 27.04.2022 CHAIRED BY SHRI ANANTA NAIK, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE of REPRESENTATION OF DR. H.K. NAGU VICE PRESIDENT, (NCST) IN THE CASE of REPRESENTATION OF DR. H.K. NAGU VICE PRESIDENT, AKHIL BHARTIYA VANVASI KALYAN ASHRAM, HYDERABAD REGARDING ATROCITY AGAINST 41 KOYA ST FAMILIES OF SEETAIGUDEW VILLAGE OF KG DISTRICT BY THE FOREST OFFICIALS AND LOCAL POLICE OFFICIALS BY WAY OF EVICTION FROM THE FOREST LAND, BRUTALLY BEATEN AND DAMAGED COTTON CROPS AND ALSO NOT PROVIDING PATTAS TO THE ST OCCUPANTS UNDER ROFR.

The petitioner, Dr. H.K. Nagu, Vice President, Akhil Bharatiya Vanvasi Kalyan Ashram, Hyderabad had submitted representation regarding atrocity against 41 Koya ST families of Seetaigudem Village of KG District by the Forest officials and local Police officials by way of eviction from the Forest land, brutally beaten and damaged cotton crops and non providing Pattas under Forest Rights Act to the STs.

- 2. Earlier the aforesaid case was taken up for sitting held on 11.03.2022 in the Commission. The Commission recommended that the District Collector, Bhadradri Kothagudem will examine all pending 03 cases of providing pattas and legal rights under Forest Rights Act to the ST occupants.
- 3. In light of the Commission's recommendations, the District Collector, Bhadradri Kothagudem had submitted an action taken report dated 21.04.2022. The action taken report was examined and found to be unsatisfactory as some ST people were not given pattas under Forest Right Acts. Hence, another sitting was held on 27.04.2022.
- 4. In the sitting, the District Forest Officer, Bhadradri Kothagudem appeared on behalf of the District Collector, Bhadradri Kothagudem. He also informed that he was instructed by the District Collector to take decisions on behalf and the Commission's recommendations and the same will be accepted by the District Administration.
- 5. The DFO, has submitted brief of all three cases and action taken by the District Administration. After detailed discussion and analysis of the case, the Commission recommends that the District Collector, Bhadradri Kothagudem will take following actions:
  - In Ist case POR No. 15/17/03 dated 23.08.2004 registered against 17 persons, issue Pattas in the name of 10 ST occupants under RoFR Act within two months period. Further, where Pattas have already been issued to the ST occupants, Patta certificates may be provided to the ST occupants with a certified copy to the petitioner.

In the 2<sup>nd</sup> case POR No. 16/13 dated 23.08.2004 registered against 19 members, issue Pattas to all 06 STs under RoFR as per rule within two months and also provide Patta certificates to all the ST occupants.

In 3<sup>rd</sup> case, Pot No. 16/31/2005 dated 28.09.2005 registered against 24 people, there were 03 ST occupants who could not issue Pattas. The District Administration may issue pattas to all 03 ST occupants with providing certificate of Patta under RoFR to the ST occupants.

An action taken report along with certified copies of the Pattas issued to all ST occupants in 03 cases be submitted before the Commission within two months.

 Next date of sitting will be held on 05.07.2022, if the action taken report found to be unsatisfactory.
