



Minutes of the Sitting held on 03/08/2022 at 3 PM under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, New Delhi on the petition of Shri Sunke Kistaiah regarding illegal encroachment of Land and subsequent harassment due to inaction of the district administration.

- In the given matter, the petitioner Shri Sunke Kistaiah alleges illegal Encroachment of land, Caste Abuse and Police Inaction. The petitioner has alleged that he is having land of 1.55 Acre in Sy. No. 26/A and 26/B in Ankusapur Village of K B Asifabad District (Telangana). This land was purchased in the year 2001 by registered deed. However, this land was grabbed by some non ST persons claiming that they have purchased this land long back without showing any legal documents.
- Pursuant to the notice issued by the Commission the Action Taken Report submitted by the District Collector & District Magistrate, Kumauram Bheem Asifabad stated that the disputed land forms part of the survey number and many others also have possession over the land and the sale deed was an un-registered sale deed and there were so many suspicious grounds on the transactions.
- The petitioner also failed to show his possession over the land and the petitioner is neither pattadar nor possession over the land in question and the petitioner has never approached the competent authorities under LTR, 1950 for issuance of 'L' form and 'K' form for getting patta rights.
- The petitioner in response has said that the RDO did not come with the proper documents and records that is why he was not able to demarcate the said land.
- The petitioner said that their land has been encroached, due to inaction of the administration they are not in possession of the land. The petitioner said that there is a Sada Bainama/unregistered sale deed which the authorities never questioned and believed in its genuineness.
- The petitioner's name is there in the in the name of the possessor certificate produced by the petitioner. The DM also agreed to the submission made by the petitioner .He expressed his inability to adjudicate this matter as he is not authorised by law however he suggested that the petitioner may approach PO, ITDA for redressal of grievances.
