
This is in continuation of earlier proceedings of 21.02.2023 wherein the Commission made the following recommendations to the District Collector, Jalgaon, Maharashtra:

- vii. "to conduct an independent and impartial investigation of the matter and submit detailed investigation report failing which inquiry will be conducted against them.
- viii. to send the relevant documents, Power of Attorney, File Notings, Correspondence, Office Records pertaining to the case.
- ix. to provide the Lay out plan, Village plans of Shirsoli. Tah:- Jalgaon, District:- Jalgaon state since 1950,
- x. to provide the details including the names, current residential addresses, mobile numbers of the officers the Collectors, Tehsildars, Nayab Tahsildars, Talathi from the year 1965, who held the post of the Collectors, Tahsildars, Nayab Tahsildars, Talathi from the year 1965, in the areas wherever the land of Jain Irrigation System Ltd. is situated in the district.
- xi. To take both Civil and Criminal Action against the wrongdoers.

On 13th March, 2023, the District Collector, Jalgaon, Maharashtra will appear in person before the Commission with all the original documents required.

Action Taken Report(ATR) with compliance of the Recommendations must be submitted within a period of 15 days."

During the Course of hearing held on 13.03.2023, the District Collector, Jalgaon, Maharashtra was present along with a law officer. He submitted documents including a master file, 19 original files, 19 documents pertaining to registration of lands, Naksha and Layouts, officer's details (except some phone numbers), noting and communications in accordance with the recommendations of the Commission. The District Collector, Jalgaon also submitted that the investigation is going on and it will take some time to be completed.


After hearing the Commission recommended the followings: -

The District Collector, Jalgaon, Maharashtra

1. To submit details including the names, current residential addresses, mobile numbers of sub-registrars from the year 1950 that had worked in the district in the district
2. To submit old nakshas and layouts for comparison purposes
3. To submit original documents of all the copies submitted for verification purposes

The Commission may order a visit to the Collector's office for verification of documents and might call the Power of Attorney holders, victims or petitioners in case of necessity.
