Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Shri Bhagyawan, Video Executive, Doordarshan, Hyderabad regarding denial of promotion by his department.

Shri Bhagyawan, Video Executive, Doordarshan, Hyderabad vide his email dated 29.04.2022 has forwarded his representation dated 26.04.2022 and alleged that the Prasar Bharti Administration is doing injustice with him because his promotion was delayed by 8 years when he had become eligible in 2009 only. But he was actually promoted in 2017. Since 2018, he has filed several applications requesting that he be promoted to the next higher post of JAG by relaxing service conditions since the post has many vacancies and his earlier DPC was delayed by so long. But the department has not done anything.

He has also complained that an Engineer from outside has been declared as Head of Programme which is humiliating and instead he should have been appointed the head of programme.

NCST vide notice dated 10.06.2022 had referred the matter to Shri Mayank Agrawal, Director General-News and CA, Doordarshan, Copernicus Marg for furnishing the facts and comments within 30 days of the receipt of the notice. The Director General (Doordarshan), vide letter dated 04.10.2022 had furnished the facts and comments which was communicated to the petitioner.

The petitioner vide rejoinder dated 10.02.2023 has refuted the facts and stated that he has filed an application to DG, Doordarshan on 19.12.2022 which was referred to Doordarshan for facts and comments. There was no response.

The Hon'ble Member, NCST, has decided to discuss the issue with the authority and petitioner on 27.04.2023 at 11:00 AM. Accordingly, the Summon was issued to Dr Shri Mayank Agrawal, Director General-News and CA, DoorDarshan, Copernicus Marg.

The petitioner was also informed to attend the sitting. The Chief Executive Officer vide letter dated 25.04.2023 has furnished the facts and comments and stated that the post of Director General and CA is vacant since 28.02.2023. Therefore, the officers from Prasar Bharti will appear before the commission on 27.04.2023. In the letter, it has been also informed that the DPC for promotion from VEX to JAG has already been conducted on 19.04.2023 and the requisite promotion order will be issued after the competent authority.

The petitioner has requested the Commission to allow his representative to attend the sitting as he met with an accident and on hospital bed.

During the discussion, the officers of Prasar Bharti informed that the file is under submission with the Hon'ble Minister for approval. After that, the promotion order will be issued.

After hearing both the sides, the Commission recommends that the Prasar Bharti to provide the status of the promotion order within 15 days of the date of receipt of the Minutes. The petitioner was also advised to submit the representation mentioning the appointment of Head of Programme (HoP) from VEX services on earlier dates.
