Minutes of the sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, in the case of Shri Kailash Meda& others, Jhabua District, Madhya Pradesh State Regarding the 806 ST families of 12 Villages have been affected by Mahi Dam project in 1992 are not been Compensated accordingly

Date of the sitting: 26.04.2023

Shri KailashMeda and others from Jhabua District, Madhya Pradesh, in their representation dated 11.10.2022, have alleged that 806 families belonging to Scheduled Tribes of 12 villages were forcefully evacuated in 1992 in name of the construction of Mahi Dam without any prior notice. They have also not received adequate compensation from the authorities to this date. The Petitioner has time and again requested the concerned authorities to take appropriate action. However, it was only in 2021, after a very long periodof over 15 years, the Sub-divisional Magistrate ("SDM") formed a committee to investigate the matter. Thereafter, the authorities promised the Petitioners that they would be compensated within 3 months, but the Petitioners have not received any compensation. In the neighboring Dhar District, the all the families affected due to the construction of Mahi Dam have received full compensation. Further the Petitioner submitted that on the demand of the villagers, the SDM visited the affected villages of Jhabua with a Tehsil team and promised that he would investigate the matter, but didn't investigate. The authorities are time and again making false promises and not taking any action

Considering the gravity of the issue, the Commission issued a notice to the Principal Secretary, Department of Tribal Affairs, Govt of Madhya Pradesh, the Addl. Chief Secretary, Water Resources Department, Govt of Madhya Pradesh, and the Collector & District Magistrate, Jhabua District, Madhya Pradeshon 18.11.2022. However, no action taken report (ATR) was received from the authorities

Since the Authorities failed to act upon the issue, the Commission held a Sitting on 08.12.2022 and based on the submissions made by the Petitioners and the Collector & District Magistrate recommended the District Collector to make discreet enquiry of the whole matter by constituting District Level Committee and send detailed compliance report within 30days

Keeping in view of the seriousness of the issue and the lackadaisical attitude of the authorities on taking action as per the recommendation of the Commission within the given period, the Commission issued summons to Shri Manish Rastogi, Principal Secretary, Department of Revenue, Govt of Madhya Pradesh, Dr. Pallavi Jain Govil, Principal Secretary, Department of Tribal Affairs, Govt of Madhya Pradesh, Shri S.N. Mishra, the Additional Chief Secretary, Department of Water Resources, Govt of Madhya Pradesh and Ms. Tanvi Hooda, Collector & District Magistrate, Jhabua District, Madhya Pradesh to appear before the Commission on 26.04.2023. The Principal Secretary, Department of Revenue, Govt of Madhya Pradesh did not appear.

The Commission further constituted an investigation team on 19.04.2023for investigation and fact-finding in the matter. The Commission's Investigation Team in its Report dated 24.04.2023 stated that the allegations made by the Petitioner against the authorities were true. The Investigation Team found that the authorities have not conducted proper survey of the land and that the calculation of the compensation by the authorities is not proper. Due to the negligence on part of the authorities, the Petitioners and their family are deprived fair compensation and livelihood.

In the sitting the Petitioner submitted that they have been evacuated without any prior notice. Thereafter, theauthorities have not calculated the compensation properly and have awarded a meagre amount of just Rs. 84,000 per hectare to these 12 villages. However, the neighboring affected villages of Dhar district have received compensation which is double the amount of the compensation received by the Petitioners also through Collector of Jhabua in 2013. He further stated that the affected families of Jhakanavadh Village have got an amount of Rs. 8Lakh per hectare to irrigated lands and Rs. 4 lakh per hectare to non-irrigated lands. He pointed out that Jhakanavadhwas just 3-4km away from these 12 villages, but these 12 villages were not taken into

consideration for the calculation of compensation. The Petitioners have made several requests to District administration but they not taken any action till date.

Shri S.N. Mishra, the Additional Chief Secretary, Department of Water Resources, Govt of Madhya Pradesh submitted that for Mahi Dam, the special rehabilitation grant was calculated and compensation was awarded to the Petitioners by considering the Sakalda command area as the base as per the Circulardated 27.12.2002. He further submitted the calculation of compensation awarded to each Petitioner before the Commission. He further submitted that the site was inspected by the officers of the Revenue Department, Public Works Department, Public Health Engineering Department and Forest Department for the houses, agricultural land, assets located on the land andareas submerged due to the Mahi Dam project.

Ms. Tanvi Hooda, the Collector and District Magistrate, Jhabua District, Madhya Pradesh stated that the District Water Resources Department had conducted a survey by visiting all the affected families of 12 villages in the matter. The villagers have filled out forms and submitted them to the administration. The team is currently assessing the forms, and based on the analysis, a report will be submitted to the Commission.

The Investigation Team submitted thatbased on their interaction with the affected families of the villages, they found out that families had to face severe hardship due to the forceful evacuation and negligence of the authorities. The villagers had to spend nights without shelter, their cattle and livestock died due to scarcity of water and children were suffering frommalnutrition. Even while compensation was awarded to the families, they were not calculated properly and the calculations were biased against the villagers of Jhabua District, Madhya Pradesh.

Based on the submissions made, the Commission observed that there was no clear policy for the rehabilitation with respect to Mahi Dam has been made to date, there was bias in the calculation of compensation towards the affected families from the Jhabua District, Madhya Pradesh and that the community rights of the village were not properly assessed, along with the individual rights of the Petitioners



After the discussion, the Commission recommends the following:

- Additional Chief Secretary, Department of Water Resources, Govt of Madhya Pradeshwill submit the full details of the Mahi Dam Project; calculation of the compensation provided to the Petitioners; date, calculation of compensation, amount of compensation and the guidelines followed in Dhar and Jhabua districts of Madhya Pradesh.
- Collector and District Magistrate, Jhabua, Madhya Pradeshwill submit the full details
 of date, calculation of compensation, amount of compensation and the guidelines
 followed in 2015 to the families of Jhaknawad Village, Jhabua District, Madhya
 Pradesh.
- Collector and District Magistrate, Jhabua, Madhya Pradesh willconstitute District Level Committee(DLC) whichshall include tworepresentatives belonging to Scheduled Tribes from reputed NGOs working in the region and one representative from each of the 12 villages.
- 4. The Collector and District Magistrate, Jhabua, Madhya Pradeshwillensure that the 2 representatives from the NGOs and 12 villages areappointed to the DLC are based on the selection and written consent of the Petitioners. The constitution of the DLC and the written consent of the Petitioners shall be submitted to the Commission within 7 days.
- The DLC will inquire into all the issues raised by the Investigation Team of the Commissionincluding those that were pointed out inthe Sitting.
- 6. The DLC will visit all the 12 villages with prior intimation to the villagers and conduct Gram Sabhas to understand/asses the issues. The Gram Sabha proceedings/minutes of each village shall be recorded and annexed to the final report.
- The DLC shall complete and submit the inquiry report within 30 days
