Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST on representation filed by Shri Manoj Kumar Agaria, Village Ghutuwa, Post Naya Nagar Barkakana, District Ramgarh, Jharkhand regarding the police inaction to register FIR against the accused for castebased abuse, assault and cheating of a Scheduled Tribe (PVTG) woman and her family.

Date of the Sitting: 13.04.2023 at 12:00 PM

The Commission received a representation from Shri. Manoj Kumar Agaria stating that his wife met the accused in 2016 belonging to the accused. The Petitioner, his wife and the accused agreed on an amount of Rs. 20 lakh as consideration for the land. On 19.08.2016, they executed an agreement for sale for which the Petitioner and his wife made a payment of 4,50,000 as advance. Thereafter, the Petitioner and his wife made a total payment of Rs. 15,60,000 on different dates through cash and cheques. Thereafter, the accused kept delaying the delivery of documents pertaining to the land from 2017. When nothing happened after repeated requests, the Petitioner and his wife visited Smt. Anjali Kujur, and Shri. Mukesh Kuju's house on 20.02.2022 and got to know that they had no intention of selling the land to them and that they had already planned on selling the land to someone else. When the Petitioner and his wife questioned them on cheating, they started using foul language, threatened them, beat them up and asked them to leave the house. They further stated that they had a lot of connections in the Ranchi Police Department.

Considering the gravity of the issue the Commission issued Notice to the Senior Superintendent of Police, Ranchi District, Jharkhand on 11.11.2022 to submit the Action Taken Report within 15 days.

अनंत नायक/ANANTA NAYAK सदस्य/Member राष्ट्रीय अनुसूचित जनजाति आयोग NATIONAL COMMISSION FOR SCHEDULED TRIBES भारत सरकार/Govt. of India नई विल्ली/New Delhi Since the Authorities failed to respond in time, the Commission issued Summons to the Senior Superintendent of Police, Ranchi District, Jharkhand on 28.03.2022 asking him to appear before the Commission on 13.04.2023 at 12:00 PM. for hearing.

During the course of hearing, the Petitioner submitted that he and his wife had met up with all the authorities and had requested them to look into the case. The Petitioner further informed that he had mortgaged his house and given the money to the accused. The Petitioner had paid a total amount of Rs. 17 lakh only as interest on the mortgage. The accused admitted in their reply to legal notice that they owed payment to the Petitioner, but until date had not returned even a single rupee.

Shri Haris Bin Zaman, Superintendent of Police, Ranchi District, Jharkhand submitted that they had taken disciplinary action against the Officer who had refused to investigate the Petitioner's complaint. He further submitted that the accused had through their advocate replied to Section 41A notice issued by the Police and admitted that they had taken the money from the Petitioner. The investigation was in the final stage.

After hearing both the sides, the Commission recommends the followings: -

- 1. The Senior Superintendent of Police, Ranchi District, Jharkhand will file the challan in the said case within one month and submit the Action Taken Report
- 2. The Senior Superintendent of Police, Ranchi District, Jharkhand will furnish all the documents related to the investigation of the case within three days.
