Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST on the representations of Shri Kuthadi Srinivas regarding implicating in false cases and threatening to compromise

Date of the Sitting: 27.04.2023 at 04:00 PM

The Commission received representations from the Petitioner stating that he and one Shri Lakshmikanta Panda were business partners in real estate, cold storages, warehousing etc. since 2018. They had certain business issues which ended up in civil litigation. The petitioner further stated that after the business relationship, the business partner instigated another person and started filling false cases against the Petitioner and further threatened the Petitioner that if he doesn't compromise, then he will go ahead and start filling cases under the Preventive of Dangerous Activities Act ("PD Act"). The Petitioner has reported the harassment by the business partner to the SHOs of Jawaharnagar, Neredmet, Basheerabad and Medchal, the Commissioners of Rachakonda and Cyberabad and the Director General of Police, but the authorities took no action.

Considering the petition, the Commission issued Notice on 14.12.2022 to the Director General of Police, Government of Telangana; the Commissioner of Police, Cyberabad, Government of Telangana and the Commissioner of Police, Rachakondam, Government of Telangana to submit action taken report ("ATR").

The Commission received ATR from the Commissioner of Police, Rachakonda dated 22.12.2022 stating that Petitioner and his business partner had executed joint land development agreements between themselves. Thereafter, disputes arose between both of them regarding the land. Subsequent to this, the business partner lodged complaints against the Petitioner. A total of 17 cases have been lodged against the Petitioner in different Police Stations and a Rowdy Sheet is also maintained at Jawaharnagar Police Station.

The Commission received Rejoinder filed by Petitioner's son dated 20.02.2023 stating that the Petitioner was under judicial custody. Apprehending a threat of being arrested under the PD Act, the Petitioner filed for anticipatory bail before the High Court and the High Court had granted interim order in favour of the Petitioner. Despite this, the police of Cyberabad arrested the Petitioner in front of all the friends and family while the Petitioner was performing the marriage of his second son. Out of the 17 cases listed out in the ATR of Commissioner, Rachakonda, 12 cases have already been close on grounds of it being quashed by the High Court, closed by police for lack of evidence or after entering compromise. In the other 5 cases, the High Court had granted interim orders in favour of the Petitioner.

The Commission received ATR from the Director General of Police, Government of Telangana stating that the allegations raised by the Petitioner were wrong. There were no false cases filed against the Petitioner and that the Petitioner has filed the complaint before the Commission as a counter blast to the cases registered against him.

The Commission issued Summons to the Director General of Police, Government of Telangana; Commissioner of Police, Cyberabad, Government of Telangana; and Commissioner of Police, Rachakondam, Government of Telangana to appear before the Commission on 27.04.2023 at 03:00 pm.

On the Sitting dated 27.04.2023, the Commission asked both the sides to lay down their cases. The Commission further asked the authorities deputed to appear on behalf of the DGP to explain the inaction on their part in submitting the ATR within the stipulated time.

Shri Kuthadi Kumar, the Petitioner submitted that the police with the intention of harassing the Petitioner in front of his friends, family and society arrested the Petitioner from his son's marriage. Around 107 policemen came to the venue of marriage to arrest the Petitioner. Police files false cases against the Petitioner, arrested him and made the Petitioner spend 56 days in judicial custody unnecessarily. In addition to this, the police were trying to unnecessarily complicate the dispute by playing the role of a middlemen. The Police was deliberately not taking action as they wanted some kind of monetary incentive from the Petitioner.

Shri Sundeep, Deputy Commissioner of Police, Medchal, Cyberabad ("DCP") deputed to appear on behalf of the DGP submitted that they have taken action against the accused according to the procedure of law. He further submitted that the claim of the Petitioner that he repeatedly visited the office of the police and requested them to take action. He was meeting the Petitioner for the first time. He had met only the Petitioner's son earlier.

The Commission observes that there are certain lapses in the version of the Police and the statements of the petitioner. The Commission notes the version of the Police regarding the antecedent of the petitioner as well. The Commission expresses disappointment over the handling of the matter by the police and delaying attitude in submitting the ATRs within the stipulated time. The Commission notes the version of the Police regarding the antecedent of the petitioner as well.

After careful consideration of the submissions from both the sides the Commission recommends the followings to be complied by the DGP, Telangana –

- 1. to take appropriate action as per applicable laws in the facts and circumstances of the case.
- 2. to conduct a fair and unbiased investigation based on the complaints filed by the Petitioner and submit ATR on the same.

The DGP, Telangana has to submit the compliance of the Recommendations of the Commission within 15 days.
