Minutes of the sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Mohan Lal Meena, Assistant Director, Commission for Scientific and Technical Terminology regarding grant of MACP and promotion.

Participants in the Sitting - As per Annexure

Shri Mohan Lal Meena, Assistant Director, Commission for Scientific and Technical Terminology, Delhi has stated in his representation dated 30.12.2022 that he has not been given benefit of MACP and is also being deprived of promotion.

The NCST vide notice dated 29-03-2023 had referred the matter to Chairman. Commission for Scientific and Technical Terminology and Secretary, Ministry of Education, Department of Higher Education, New Delhi. In response to NCST Notice dated 29.03.2023, Commission for Scientific &Technical Terminology, Govt. of India, vide letter dated 19.04.2023 has furnished the facts and comments and stated that the file regarding promotion of Shri Mohan Lal Meena, Assistant Director to the post of Deputy Director has been sent to the Ministry of Education for action. It was also stated that that Mr. Mohan Lal Meena has also filed a case in CAT regarding his seniority and promotion.

Shri Mohan Lal Meena vide his reply dated 10.05.2023 has expressed his dissatisfaction and refuted the facts and comments. He has stated that he has approached CAT to get his seniority corrected and that it is not a case for promotion.

GIFIC FIZIGIAN ANTA NAYAK पास्या/Member पास्या अनुसूचित जनजाति आयोग NATIONAL COMMISSION FOR SCHEDULED TRIBE भारत सम्बद्धार Government The applicant has stated that he should get the benefit of MACP and should also be promoted to the post of Deputy Director from 01.02.2023. The Commission decided to discuss the issue with the authorities and petitioner on 15.6.2023 at 02:30 PM. Accordingly, the summon was issued to Prof Girish Nath Jha, Chairman, Commission for Scientific and Technical Terminology to appear on 15-06-2023 and the petitioner was also informed to attend the sitting.

The Authority and the petitioner appeared before the Commission. The authority informed that the proposal for promotion has been submitted to the Ministry of Education on 06.06.2023. As and when, the formality is completed; the promotion order will be issued. With regards to MACP, the case will be examined in consultation with the Ministry of Education.

After hearing both the sides, the Commission recommends the followings and suggested that the action taken report may be submitted to the Commission within 30 days:-

- The proposal for grant of 2<sup>nd</sup> MACP of the petitioner to be examined as per guidelines of DOPT issued in 2019 in consultation with Ministry of Education.
- The status of promotion to the post of Deputy Director in favour of the petitioner may be informed to the Commission within 15 days from the receipt of minutes.
