Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Rudra Singh Rana, DGM, ONGC Jorhat Assam regarding his promotion.

Date of the Sitting: 07/07/2023, 11:60 AM

Participants in the Sitting - As per Annexure

Shri Rudra Singh Rana, in his representation sent vide email dated 26.02.2022 along with supporting documents in respect of his case for not granting promotion from E-5 to E-6 by the ONGC. He has alleged that the juniors have been promoted from E-5 to E-6 in 2020. But administration has not considered for promotion to the next grade. Hence he has approached the Commission for justice.

The NCST vide notice dated 29-06-2022 had referred the matter to the Chairman cum Managing Director, ONGC, New Delhi and requested to furnish the facts and comments within 30 days from the receipt of the notice.

Pursuant thereto, the ONGC vide letter no. DDN/CORP- PROM/2022/NCSC/AMD dated 05.09.2022 has furnished the facts and comments and stated that the representation of Sh. Rudra Singh Rana, DGM (Geophysics-Surface) has been examined and it is informed that the executive of 2015 batch of E5 level were considered for the first time of selection for promotion from E5 to E6 level w.e.f. 01.01.2020 only. However, he was not recommended for promotion by the respective Departmental Promotion Committee, as he could not achieve the required bench- mark/cut-off marks decided in the process.

The Commission forwarded the reply of ONGC vide letter dated 26.10.2022 to the petitioner for information.

After carefully examining the petition and the reply submitted by the ONGC, Summons was issued to Shri Arun Kumar Singh, Chairman and CEO, ONGC, New Delhi

अनंत नायक/ANANTA NAYAK सदस्य/Member राष्ट्रीय अनुसूचित जनजाति आयोग on 30- 05-2023 and the petitioner was also informed to attend the sitting, which was postponed and re-fixed on 07.07.2023 at 11: 00 AM.

The Director, HR appeared on behalf of Chairman and CEO, ONGC. The petitioner also attended the Sitting. During the course of hearing both the sides reiterated their earlier stands.

After hearing both the sides, the Commission recommends ONGC to send a report regarding the following –

- The composition of the DPC for the meetings held in years 2020, 2021, 2022 and 2023.
- The criteria for selection/promotion adopted in the above meetings of DPC.
- A comparative statement of the candidates including the petitioner, considered for selection to the next higher post of DGM in the above meetings.
- The Commission strongly believes "Justice should not only be done but should be seen as done". The representative of ONGC informed that the SC/ST members have been nominated in the DPCs/Selections Committees of the organization. Since the National Commission for Scheduled Tribes and National Commission for Scheduled Castes have been bifurcated, therefore in the same way, an ST Member may be nominated/appointed in each DPC/Selection Committees of ONGC to ensure justice to STs.
- An Internal Grievance Committee for STs to be constituted as the NCST had already advised to the ministries of the departments vide letter DO NO 18/01/NCST(IGRC)/2021-Coord dated 03-08-2021 (Copy enclosed).

The Action Taken Report in compliance of the Recommendations to be submitted within a month of receipt of these minutes for further perusal of the Commission.
