Shri Amarsingh Z Chaudhary (Ex. MP and Ex. M.L.A) District-Tapi (Gujarat) vide letter dated 15.12.2021 has referred the letter dated 07.12.2021 of Shri Kartik R. Bhil, Ahemdabad (Gujarat) regarding inaction by Bank of Baroda on the papers submitted for Compassionate Appointment to the dependents of deceased employees of Bank of Baroda, namely Shri Rameshbhai K. Bhil, working as clerk in Girdharnagar Branch of Bank of Baroda died on 04.08.2020. The papers submitted by Shri K. R. Bhil to Bank have also been enclosed with the representation.

The NCST vide notice dated 16-01-2023 had referred the matter to the Managing Director and CEO, Bank of Baroda and requested to furnish the facts and comments within 30 days from the receipt of the notice.

Pursuant thereto, Bank of Baroda vide letter dated 09.02.2023, has stated that Shri Bhil Ramesh Keshaji died on 04.08.2020, at the age of 55 years 4 days. Compassionate appointment is applicable only when the person dies before 55 years of age. In this case, ex-gratia financial relief is applicable and the bank has asked the petitioner to apply for ex gratia financial relief which shall be sanctioned by the Bank.

NCST vide letter dated 14.03.2023 had forwarded the reply of Bank of Baroda to the petitioner for information. The petitioner vide his rejoinder dated 05.04.2023 has stated that Bank of Baroda is applying the new circular which is applicable from 01/12/2020 and denying him compassionate appointment. The old circular which was applicable when his father died, allows him to get compassionate appointment even if his father had crossed 55 years of age. Hence Bank cause injustice with him.

After discussion with the petitioner and the MD and CEO, Bank of Baroda, the Commission recommends that Bank of Baroda should re-examine the issue as per provisions of Para 1.1(a) of the circular number BCC: BR:108:82 dated 18/02/2016 issued by Bank of Baroda for the "Scheme for Compassionate Appointment or Payment of ex-Gratia Financial Relief to dependants of deceased employees on compassionate grounds."

The Action Taken Report in compliance of the Recommendations to be submitted within a month of receipt of these minutes for further perusal of the Commission.
