

Minutes of Meeting held on 07.11.2023 Chaired by Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes (NCST) in the case of Shri Piniya Naik, 1-6, Mundadi Melmane, Kadoor Village, Bramhavara Taluk, Udupi- 576 234- Karnataka regarding constant abuse, harassment and intimidation through casteist remarks, black magic and putting nails on the road cutting access to temple, school, agriculture work and houses.



The Commission received a representation dated 15.03.2023 from Shri. Piniya Naik regarding constant abuse, harassment and intimidation through casteist remarks, black magic and putting nails on the road cutting access to temple, school, agriculture work and houses by the non-applicant.. The Petitioner has stated in his representation that Shri. Balakrishna Vaidya is constantly abusing, harassing and intimidating the members of the Scheduled Tribes community by resorting to casteist remarks, black magic, putting nails on the road cutting people's/children's access to temple, school, agriculture work and houses. The petitioner requested for inquiry and an appropriate investigation in the matter.

2. The Commission took up this matter with the Deputy Commissioner and District Magistrate and Superintendent of Police, District Udupi, Karnataka on 11.05.2023.
3. In response to the Commission's notice dated 11.05.2023, an ATR dated 29.05.2023 was received from the Superintendent of Police, Udupi, Karnataka and ATR dated 09.10.2023 received from Deputy Commissioner and District Magistrate, Udupi in the matter.
4. On perusal/examination of reply of Superintendent of Police, Udupi and Deputy Commissioner and District Magistrate, the Commission has fixed a Meeting with the Deputy Commissioner and District Magistrate, Udupi and Superintendent of Police on 07.11.2023.
5. Deputy Commissioner and District Magistrate, Udupi and Superintendent of Police appeared before the Commission. The petitioner was present through audio conferencing in the Meeting.
6. The matter was discussed in detail with the Authorities and the petitioner.

The Deputy Superintendent of Police, Udupi Sub Division submitted that the dispute between the parties is of civil nature, for which the SHO, Brahmavar has made letter correspondence to the Tahasildar, Brahmavar Taluka and Panchayath Development Officer of kadoor Village Panchayath. It is also reported that the issue is mainly about the use of land bearing Survey No. 119/3 belonging to the counter petitioner Shri Balakrishna Vaidya, but there does not exist any matter of caste based conflict between the petitioner and the opponent.

Deputy Commissioner and District Magistrate submitted that the dispute between the parties is of civil nature, the issue is mainly about the use of land bearing Survey No. 119/3 belonging to the counter petitioner Shri Balakrishna Vaidya, but there does not exist any matter of caste conflict between the petitioner and the opponent and the petitioner himself intimated in writing that there is no obstacles from the counter petitioner for the




movement of school children and public through the above said road. At present, instructions have been issued to opponent not to harass the petitioner in future and he has agreed to give path way or road through the Survey No. 119/3 of Kadoor Village belonging him. He has also has sent mail stating that at present, the counter petitioner Shri Balakrishna Vaidya is not causing any obstacle for people to access the road.

7. After hearing, the Commission recommends that:

- A pathway for passing for the petitioner and other villagers may be provided by the District Collector as soon as possible.
- The pathway may be opened for public use in side of the opponents land for which he has agreed and/or Government land permanently within a period of six Months.
- Local Police to keep close vigil to ensure that no obstacle in usage of path is created again by the opponent.

Action taken report may be submitted to the Commission within 30 days.
