Minutes of the meeting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri B Chekre Naik, General Secretary, All India Central/PSUs and State Government, Scheduled Tribes Employees Welfare Association, Andhra Pradesh, regarding non promotion of ST Employees to Executive Engineers by R&B Department, Government of Andhra Pradesh

Shri B Chekre Naik, General Secretary, All India Central/PSUs and State Government, Scheduled Tribes Employees Welfare Association, Sarada Nagar, Andhra Pradesh vide representation dated 24.07.2023 has alleged that the Department of Transport, Roads and Building, Govt. of Andhra Pradesh is not implementing the recommendations made in the sitting held on 24.12.2019 under the Chairmanship of the then Hon'ble Chairperson, NCST, which was forwarded to Chief Secretary, Govt. of Andhra Pradesh and Principal Secretary, Transport, Roads and Building Department, Govt. of Andhra Pradesh on 20.01.2020.

2. The recommendations of the Commission made during the Sitting held on 24.12.2019 are reproduced as follows –

“The Commission took a serious note about not resolving the grievances of STs. The Commission also felt that it is a genuine grievances of Scheduled Tribe employees wherein they were deprived of promotion for the last several years. The Commission recommended to the Engineer in Chief, Road and Building Department, Andhra Pradesh to expedite the matter on priority basis and time bound manner. The Commission also recommends that the Special Chief Secretary, Transport, Roads & Buildings. Department, Andhra Pradesh will monitor the case and will take necessary action to promote all eligible ST candidates to the post of Executive Engineer within two months time positively and submit a copy of the promotion orders of the ST candidates to the NCST. It should be also ensured that there is no delay in resolving the matter and no injustice should be meted out towards ST candidates. An action taken report be also intimated to the Commission in the stipulated period.”

3. NCST vide Notice dated 08.08.2023 had taken up the matter with Chief Secretary, Govt of Andhra Pradesh and Principal Secretary, Transport, Roads and Buildings Department, Govt. of Andhra Pradesh for furnishing the facts and comments within 15 days from the receipt of the Notice. The reply / response was not been received from the authorities.



4. The Commission decided to discuss the issue with Principal Secretary, Transport, Roads and Building Department, Govt. of Andhra Pradesh and petitioner on 06.11.2023 at 03:30 PM. This was informed to the petitioner and authority on 20.10.2023.

5. The Principal Secretary, Transport, Roads and Building Department, Govt. of Andhra Pradesh, vide letter no 844424 RDBS0ENC(PROM)/14/2019-SER-RB dated 04/11/2023 has furnished the detailed report on the representation of the petitioner. The Engineer in Chief(R&B) Administration, Govt. of Andhra Pradesh, appeared before the Commission on behalf of the Principal Secretary. He reiterated the submissions made in the letter and stated that the Hon'ble High Court of Andhra Pradesh had passed a status quo order in WP No 14902/2023 on 23-06-2023.

6. After hearing both the parties, the Commission has decided not to pursue the matter as the subject matter of the petition is sub judice before the Hon'ble High Court of Andhra Pradesh. However, action taken report on the recommendations of the NCST sitting 24-12-2019 in a chronological manner may be sent to the Commission within a month of the receipt of the minutes.
