

Minutes of the meeting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Vice-Chairperson (Acting), National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Smt. Movalyza Dkhar, Data Processing Assistant Grade II, North Eastern Indira Gandhi Regional Institute of Health & Medical Science (NEIGRIHMS), East Khasi Hills, Shillong regarding correction in seniority list

Date of the meeting: 06.02.2024, 12:00 Noon

Smt. Movalyza Dkhar, Data Processing Assistant Grade II, North Eastern Indira Gandhi Regional Institute of Health & Medical Science, Shillong vide her representation dated 25-07-2023 informed the Commission that she had appeared for the exams held for the post of Data Processing Assistant Grade II at NEIGRIHMS. The petitioner after securing 82 marks which was the highest marks was however placed at a lower rank to a candidate who secured 80 marks. She had approached the officials informally but to no avail.

The Commission vide notice dated 04.09.2023 had referred the matter to Director, NEIGRIHMS, Meghalaya for furnishing the facts and comments.

NEIGRIHMS vide letter dated 05.10.2023 has furnished the facts and comments, stating that the results of the written exams conducted were declared and notified on the website based on the written examination. Subsequently, information was uploaded in the public domain (Website, Notice Board) regarding candidates provisionally selected for appointment as per the merit list. A draft seniority list was circulated to all concerned Data Processing Assistant Grade-II, inviting comments/observations. In the absence of any comments from the concerned employees, the seniority list was finalized. The above comments were forwarded to the petitioner for information on 08.11.2023. The petitioner vide letter dated 28.11.2023 has refuted the facts/comments and requested for justice.

The Commission decided to hold a meeting with Director, NEIGRIHMS and the Petitioner on 06.02.2024 to discuss and resolve the issues which was conveyed on 22.01.2024. NEIGRIHMS vide letter no NEIGR-1/52/2002/Vol.II/542 dated 31.1.2024 has informed the petitioner and copy endorsed to the Commission, that the Institute has examined her representation/rejoinder and it appears that prima facie an error seems to have crept in while finalizing the seniority list for the post of Data Processing Assistant Gr.II. Accordingly, the Institute is considering a review of the case after following due process.

In the meeting, the Director, NEIGRIHMS and petitioner were personally present. The Director, NEIGRIHMS reiterated that there was merit in the petitioner's claim and NEIGRIHMS would review the case and revise the seniority list while following due process.

After discussion with both the parties, the Commission recommends that the revision of seniority list to be done expeditiously by NEIGRIHMS while following due process and Action Taken Report to be submitted within 30 days.
