Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri P. Prem Chand and Shri Ondru Ram Gopal (working as TTA) regarding promotion from TTA to TA and hike of salary by administration of ITDA Paderu (Andhra Pradesh).

Shri P. Prem Chand and Shri Ondru Ram Gopal, working as TTA at Paderu ITDA vide online petition has alleged that they are working like TA but not given the TA salary. The matter was brought before the knowledge of APD, Paderu, but no response was received. Due to negligence of the department, 43 TTA members are harassed and suffering financial loss. Hence, do the justice.

- 2. The Commission vide Notice of even no. dated 22.02.2022 has referred the matter to Project Officer, ITDA, Paderu, Visakhapatnam (Andhra Pradesh) and Commissioner, Panchayat Raj and Rural Development, Govt. Of Andhra Pradesh, Amaravathi, Guntur for furnishing the facts and comments. The reply was not received from the concerned authorities. The Commission decided to discuss the issue with Project Officer, ITDA, Paderu, Visakhapatnam (Andhra Pradesh) and Commissioner, Panchayat Raj and Rural Development, Amaravathi, Guntur and the petitioners on 26.06.2024 to resolve the issues. The Notice was issued on 19.06.2024 to attend the sitting.
- 3. The Commissioner, Panchayat Raj and Rural Development, Amaravathi, Guntur vide letter dated 25.06.2024 has furnished the facts and comments and deputed Manager (HR), Alluri Sitaram Raju District, Andhra Pradesh to appear in the sitting. There was no communication from Project Officer, ITDA Paderu. The Manager (HR), Alluri Sitaram Raju District, Andhra Pradesh was personally present handed over the letter dated 25.06.2024 of Commissioner, Panchayat Raj and Rural Development, Amaravathi, Guntur during the sitting. He informed that the promotion had been given to 25 employees. 10 were promoted to TA and 15 as Computer Operators and the salary has also been increased. The petitioner was contacted over telephone in the sitting regarding the confirmation of action taken by the department. He informed that he was designated as Computer Operator while he requested to work as a TA and also has been transferred.
- 4. After the discussion with officer who attended the sitting and petitioner (over telephone), the following points were recommended for taking up action by concerned department and suggested to submit the ATR by 30th July 2024. If, ATR is not received in stipulated time, the Commission may consider the issuance of summons for personal appearance of Commissioner, Panchayat Raj and Rural Development, Amaravathi, Guntur and Project Officer, ITDA Paderu:
 - 1. Department may explore avenues to promote the remaining TTAs to TAs as alleged by the petitioners.
 - 2. The petitioner and others TTAs willingness may be obtained to choose Field-job or Computer Operator, in-case the salary remains the same.
 - 3. The petitioners may be considered for promotion from back date(January 2023) and salary arrears may be paid.
 - 4. The list of all 43 TTAs who were eligible for promotion may be submitted to NCST along with their caste category.
