Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi regarding non-filling of ST post by Tourism Development Corporation Ltd, Govt of Andhra Pradesh - a online representation dated 23.10.2021 of Shri Sagina Gni Babu, 2-35, Gudem Kotna Veedhi, Vishakhapatnam, Andhra Pradesh.

Shri Sagina Gni Babu, 2/35, Gudem Kotna Veedhi, Vishakhapatnam, Andhra Pradesh has alleged he applied for post of Manager/Supervisor in Andhra Pradesh Tourism Development Corporation Ltd (Jungle Bells Tourism Hill Units / Haritha Hills Resort, Ananthagiri) but the concerned department did not respond/taken action on the application. Hence, do the justice.

The NCST vide notice dated 26.11.2021 had referred the matter to Special Chief Secretary, Tourism & Culture Department, Govt. of Andhra Pradesh for furnishing the facts and comments. No reply was received from the authority. The Commission decided to discuss the issue with Special Chief Secretary, Tourism & Culture Department, Govt of Andhra Pradesh and the petitioner on 08.07.2024. Accordingly, a Sitting Notice was issued to the concerned authority and petitioner on 28.06.2024.

The Additional Secretary, Youth Advancement, Tourism & Culture (T) Department, Govt. of Andhra Pradesh vide letter dated 07.07.2024 informed that the Special Chief Secretary has been transferred and none has been appointed for the concerned post. Hence, Front Office Manager, Andhra Pradesh Tourism Development Corporation Limited was deputed on behalf to appear before the Sitting. The petitioner had also informed that he would not be able to attend the Sitting due to non-availability of transportation.

Deputing of such a junior officer on behalf of Special Chief Secretary, Tourism & Culture Department, Govt. of Andhra Pradesh by Youth Advancement, Tourism & Culture (T) Department, Govt. of Andhra Pradesh, the Hon'ble Member took a grave concern for not respecting a Constitutional body by the officer of Govt. of Andhra Pradesh. The deputed official was not able to explain the case properly. The

It was recommended that Youth Advancement, Tourism & Culture (T) Department, Govt. of Andhra Pradesh to expedite for filling up 14 backlog ST vacancies for various posts in the Andhra Pradesh Tourism Development Corporation, as pending with MD, APTDC (from May, 2024). The application of the petitioner may also be considered on priority basis following due procedure, as per rules. The present position of the petitioner's application may also be communicated to the petitioner.

The Action Taken / to be taken report may be submitted to NCST within 30 days from the receipt of the minutes for deciding further course of action.
