## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Dr. Asha Lakra, Hon'ble Member, National Commission for Scheduled Tribes at BNR Chanakya Hotel, Ranchi, in the case of Dr Sneha Bharti Linda regarding rejection of her candidature by JPSC and not calling her for interview for the post of Assistant Professor(Physics)

Dr. Sneha Bharti Linda, Ranchi (Jharkhand) has alleged that she has obtained 48.45 marks against cut of marks for ST category was mentioned 41.45 for the post of Assistant Professor (Physics) advertised in the Advt. no. 04/2018. But, Jharkhand Public Service Commission (JPSC) has not called her to interview for the post of Assistant Professor (Physics). JPSC has published the provisional list of candidate in June, 2022, wherein she found eligible for the post of Assistant Professor (Physics). JPSC has not called her for interview.

NCST vide notice dated 01.09.2022 had referred the matter to Chairman, Jharkhand Public Service Commission for facts and comments. No reply was received. NCST has discussed the issue with petitioner in May 2024. She informed that JPSC has neither taken any action nor furnished any facts to her. The Commission decided to discuss the issue with the Secretary, JPSC and petitioner on 13.06.2024 at 02:00 PM at Ranchi.

The Secretary, JPSC and the petitioner were personally present in the sitting held on 13.06.2024 at 02:00 PM at Ranchi. The Secretary, JPSC has informed that the petitioner had stated that she already had Ph.D Degree at the time of application while it was found later that only her thesis had been accepted by the concerned authority. The petitioner stated that she had obtained 48.45 marks while cut off was 41.45. JPSC had without any notice or explanation excluded her candidature from the list of candidates. She claimed that her PhD had been completed in time and JPSC's actions had caused great prejudice to her.

The Commission took a strong view that JPSC had not done justice with the ST Woman Candidate. If she had been informed in time and given a chance she could have clarified her position and may have been selected for the post. JPSC should take care not to repeat such incidents in the future.

After receipt of the report, the Commission will decide the further course of action —

- JPSC to form a committee to investigate the matter. In the committee one ST member may also be included.
- The JPSC may also formulate a procedure / guidelines to inform the candidates for their non eligibility for the said post.
- If, possible, the petitioner may be re-interviewed for the post and given a fair chance for selection
