Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding non-granting of notional promotion to the post of Associate Professor with retrospective effect from May 2022 against the clear shortfall ST vacancies by the administration of Sri Venkateshwara Medical College (SVMC), Tirupati. A representation dated 07.08.2022 of Shri D. Nagendra Prasad Naik, Assistant Professor, SVMC, Tirupati.

Shri D. Nagendra Prasad Naik, Assistant Professor, SVMC, Tirupati vide his representation dated 07.08.2022 has informed that the Department is not granting promotion to the post of Associate Professor retrospective w e f May, 2022, as against the clear shortfall ST vacancies. No ST band date was available in the feeder cadre at that time. Hence, do the justice.

The NCST vide Notice of even no. dated 21.10.2022 had referred the matter to Principal Secretary, Health, Medical and Family Welfare Department, Govt. of Andhra Pradesh for furnishing the facts and comments. The reply was not received.

Hence, NCST decided to discuss the issue with the concerned authority and petitioner on 08.07.2024. Accordingly, a Sitting Notice was issued to Principal Secretary, Health, Medical and Family Welfare Dept Govt of Andhra Pradesh and petitioner on 28.06.2024.

The Special Chief Secretary, Health, Medical and Family Welfare Department, Govt. of Andhra Pradesh vide letter dated 05.07.2024 requested for exemption and deputed Director of Medical Education, Govt. of Andhra Pradesh, Vijayawada to attend the meeting on his behalf, who attended the Sitting. The petitioner was not able to attend the Sitting. The Director, Medical Education, Govt. of Andhra Pradesh, informed that no promotion had been made in 2020-21 due to CoVID-19. After that, an ST female candidate was promoted in 2021-22 as per the roster. The petitioner has been promoted from Assistant Professor to Associate Professor of Pathology in the panel year 2022-23, on 28.02.2023 and posted to the Govt. Medical College, Nandyal.

After discussions with the officers of Medical Education, Govt. of Andhra Pradesh, Vijayawada, it was observed the Department has taken appropriate action in the matter and it was decided that there is no further action required to be taken by the NCST. However, it is advised that an Intern Grievance Committee to look after the problems of ST employees may be constituted in the department, as advised by NCST in August, 2021 to to all Ministries / Departments and Chief Secretaries of States / UTs (Copy Enclosed)
