A representation dated 11.04.2022 was received in the NCST from Smt. Lakshmi S.K, W/o Shri Krishna Naik, Bengaluru regarding murder of ST person Shri Raghu S.K. Naik and not taking action against the accused by the concerned Police officials. It has been alleged that her elder brother Raghu S.K. Naik was murdered by the non ST persons. Thereafter, the case was registered at Kushal Nagar Rural Police Station under Crime No. 0110/2021 under relevant sections of IPC and SCs&STs (PoA) Act. But, the Police did not investigate the matter properly and helping the accused. It has been requested the Commission to investigate the matter through higher officers of the Police i.e. DGP, Karnataka. Petitioner requested the Commission to intervene in the matter.

- 2. The Commission issued Notice to The Director General of Police and The Superintendent of Police, Bengaluru Rural, Karnataka on dated 04.05.2022 for ATR/Reply within 30 days.
- 3. In response to NCST notice dated 04.05.2022, No reply/ATR received from The Director General of Police and The Superintendent of Police, Bengaluru Rural, Karnataka. In this matter the Commission fixed a Hearing on 23.07.2024 with The Director General of Police, Karnataka and The Superintendent of Police, Bengaluru Rural, Karnataka.
- 4. The Superintendent of Police, Bengaluru Rural, Karnataka was present in the hearing. The petitioner Smt. Lakshmi S.K was not present in the hearing.

- 5. The matter was examined in detail. The Superintendent of Police, Bengaluru Rural, Karnataka presented comprehensive details of the case before the Commission. He informed that the report received from forensic lab indicates natural death. He also informed that after registering FIR second time, again CID investigated the case and reported same report. He also informed that they had done three fresh investigations in the case but each time getting same report. He also informed that deceased is not belongs to ST community and he had murdered his own mother also.
- 6. After hearing the matter, the Commission recommends that:
  - · No action required in the matter and the case to be closed
