Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Gundela Hari Krishna, S/o Ramarao and Shri Gedela Srinivasa Rao, Parvathipuram Manyam District, Andhra Pradesh regarding denial of Appointment for the post of Shift Operator in Andhra Pradesh

Shri Gundela Hari Krishna S/o Ramarao and Shri Gedela Srinivasa Rao, Parvathipuram Manyam District, Andhra Pradesh vide representation dated 19.02.2024 has alleged that they have applied for the post of Shift Operator in APEPDCL, Srikakulam. But no response was received by the department. He has stated that the department is not following the reservation rules. Gundela Hari Krishna has also enclosed the copy of the letter dated 16.02.2024, in which he had requested the CMD, APEDCL, Visakhapatnam to issue the appointment order on humanitarian ground but still no

NCST vide Notice dated 22.02.2024 had referred the matter to CMD, Eastern Power Distribution Company of A.P. Ltd, Visakhapatnam for facts and comments. In response to this, Eastern Power Distribution Company of A.P. Ltd, Visakhapatnam vide letter dated 13.03.2024 stated that a certain Shri Gedela Ravi Babu has been engaged as Shift Operator and there was no applications were received from Shri Gundela Hari Krishna. This was forwarded to petitioners for information on 22.05.2024.

Accordingly, the NCST has decided to discuss the matter with the CMD, Eastern Power Distribution Company of A.P. Ltd, Visakhapatnam and petitioner on 22.08.2024 at 5:20 PM. Hence, a sitting notice was issued to CMD, Eastern Power Distribution Company of A.P. Ltd, Visakhapatnam and petitioner on 14.08.2024. CMD, Eastern Power Distribution Company of A.P. Ltd, Visakhapatnam vide letter dated 17.08.2024 has requested for exemption and deputed Superintending Engineer (Operations) for attending the sitting. Both, Superintending Engineer, APEPDCL and the petitioners

The petitioners reiterated their previous prayers and stated that they have requested several times but the administration is not considering their application. The concerned officials informed that the respective posts are dealt through outsourced organisation and are not directly dealt by APEPDCL

After hearing both the sides, the Commission recommends the following and suggested that Action 1.

- Details of Reservation Roster for the post of Shift Operator in APEPDCL may be provided. 2
- Details of total ST employees, who were considered for the post of Shift Operator in the last two 3.
- The authorities may consider the candidature of the petitioners in the next round of recruitment
