Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri D. Poornachandar, Brahamanapally Gram, Gudur Mandal, Mabubabad regarding reinstatement in Service

Shri D. Poornachandar (Sr. Manager, Indian Bank (Dismissed)) R/o at Gudur Mandal, District- Mahbubabad vide representation dated 02.05.2024 has alleged that he was wrongly dismissed from the post of Sr. Manager by the Management of Indian Bank. He mentioned that a false complaint was lodged by the influential persons of the upper caste, that he had misused the position of Branch Manager and customer funds were diverted. Due to that he was immediately suspended by the bank and disciplinary proceedings were initiated against him. He was dismissed from the service on 27.09.2023. Thereafter, he filed an appeal before the management, but the management has not given any reply. He requested the bank management may consider his appeal and

NCST vide Notice dated 07.05.2024 had referred the matter to Indian Bank for facts and comments. No reply was received. The petitioner vide letter dated 28.05.2024 has furnished the supporting documents (i.e. Enquiry report, order of removal and copy of appeal). NCST has decided to discuss the matter with the MD & CEO, Indian Bank, Chennai and petitioner on 22.08.2024 at 4:20 PM. A sitting notice was issued to MD & CEO, Indian Bank, Chennai and petitioner on 14.08.2024.

In the Sitting, Official of Indian Bank were present while the petitioner joined on telephonic call. The petitioner suggested the previous points he mentioned in his representation. The officials of Indian Bank informed that there was a transaction from his personal account, which was against the bank rules. They also informed that the petitioner has not filed any appeal before the bank.

After hearing both the sides, the Commission recommends the following and suggested that Action Taken Report may be submitted within 30 days.

1. The petitioner is advised to file an appeal before the appropriate authority of bank management.

2. The bank is advised to consider his appeal and take necessary action for reinstating in service, on
