A Representation dated 02.01.2022 received from Shri M Mallaiah, President, Telangana ST Employees Welfare Association, Telangana. He alleged that on 31.12.2021, some anti social elements have burnt 40 huts of tribal people at Chadargat, Hyderabad. Due to this the victim ST families become homeless and they have no livelihood source. The petitioner has requested the Commission to issue necessary directions for action taken against accused, rehabilitation of victim ST families, compensation and providing residential and agriculture land.

- 2. The Commission issued Notice to The Director General of Police, Telangana, District Collector, Ranga Reddy, Telangana and Commissioner of Police, Hyderabad City, Telangana on 05.01.2022 for ATR/Reply within 03 days.
- 3. In response to the Commission's notice letter dated 05.01.2022 a reply dated 07.01.2022 received from Commissioner of Police, Hyderabad City, Telangana. wherein it was mentioned that fire was broke out accidently while a 75 year old lady was cooking food, So all other huts caught the fire and burnt completely. Because of taking prompt action by the Police authorities no casualty was reported.

- 4. The case was taken for sitting on 10.02.2022 before the Hon'ble Commission. During the sitting, it was decided that there is a pending issue of rehabilitation of ST family, non payment of compensation, education and allotment of land. Hence a rejoinder was asked from the petitioner and then, a report was sought from the District Collector, Hyderabad. Proceedings of the sitting were issued on 21.02.2022 to the concerned authority.
- 5. Compliance of the proceedings of the sitting was submitted by the District Collector, Hyderabad. It was replied that all the immediate measures have been taken for the welfare of the Fire Accident victims i.e. Food, Water, Shelter, Utensils etc. and as per the G.O.Ms. No. 3, dated 23.01.2009, Relief Assistance to the Fire Accident victims were provided as per the norms i.e. (fully damaged Rs. 4000/- clothing- Rs. 1000/-, Utensils Rs. 1000/- amounting to total of Rs. 6000/- to each household. The same has been provided to the total 20 Fire Accident victims as per the Government norms.
- 6. Another rejoinder dated 25.02.2022 was submitted by the petitioner where he submitted that the authorities are trying to displace/evacuate poor tribal families (who are living at the incident place from more than 50 years by making baskets from Eetha & Bamboo sticks) from that incident place, even though other permanent structures including Mosque and Big & Large Inter State Bus Stations of Government of Telangana are available within the Musi River Bufer Zone.

He further submitted that pay the compensation of Rs. 10 lakhs, and arrange ration for 6 months to each family, arrange to construct Market Stalls or market Yard with all facilities at the same incident place and allocate them to each family on free of charge, arrange to construct free permanent pucca house with double bed rooms to each family, provide one suitable Government job to each family and provide free education up to PG level to the children living in the incident place.

- 7. In response to NCST letter dated 14.06.2022, no reply was received from the District Collector, Hyderabad. In this matter the Commission fixed a Hearing on 22.08.2024 with the District Collector, Hyderabad and the petitioner.
- 8. The District Collector, Hyderabad called on by the Commission was not present and has authorised vide letter dated 20.08.2024, the Add. Collector local bodies, Hyderabad to appear before the commission. The said officer has appeared with the law officer collectorate, Hyderabad. Petitioner was absent in the sitting.
- 9. The matter was examined in detail. The the law officer collectorate, Hyderabad presented details of the case before the Commission.

After hearing the matter, the Commission recommends:

- To enhance the compensation of Rs. 6000(which as per the submission of the ld. Law officer has already been paid to the affected parties) to Rs. 3-5 Lakh for each affected family.
- To decide on the aspect of allotment of pucca houses to the 16 affected families as mentioned by the Ld. Law officer.
- To submit the list of affected parties with all particulars along with the compensation so awarded up till date in a systematic manner
- Action taken report may be submitted by the District Collector, Hyderabad to the Commission within 30 days.
