A representation dated 09.05.2023 from Shri Palakurthi Peda Venkateswarlu, Andhra Pradesh was received in the Commission, wherein it was stated that accused illegally grabbed the land belonging to the Petitioner, physically assaulted him and passed caste-based derogatory remarks. The Petitioner registered complaint with the Police authorities, but they have not taken any necessary action.

2. The Commission sent Notice to the Superintendent of Police, District-Guntur, Andhra Pradesh vide Notice dated 30.05.2023 for ATR/Reply within 15 days in the Commission.

3. In response to NCST notice dated 30.05.2023, Superintendent of Police, District-Guntur said that case is transferred to Palanadu District as it falls under it's jurisdiction. In this regarding Commission fixed a Sitting on 08.07.2024 with the Superintendent of Police, District- Guntur, Andhra Pradesh.

4. On behalf of the Superintendent of Police, Palanadu, Add. Superintendent of Police, Palanadu was present in the Sitting. The petitioner Shri Palakurthi Peda Venkateswarlu was not present in the Sitting.

5. The matter was examined in detail. The Add. Superintendent of Police, Palanadu presented details of the case before the Commission. he informed that the said land was sold in 1979 he also informed that the petitioner don't have any document related to the land. He further informed that false allegations are made by the petitioner.

6. After hearing the matter, the Commission recommends that:

- Land related documents in the case, may be furnished in the Commission within 15 days.
