Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding reinstatement and non-payment of salary to ST employees by Tribal Welfare Department since last two years who working in the GTWAH boys school in the case of Shri Savara Dandasi, S/o Raghu, Shri Bijayakumar Savara, Kamati and others of GTWAH Boys School, MG Puram, Sompeta Mandal, District – Srikakulam.

Shri Savara Dandasi, S/o Raghu, Shri Bijayakumar Savara, Kamati and others of GTWAH Boys School, MG Puram, Sompeta Mandal, District- Srikakulam vide their representation dated 12.08.2022 have stated that since more than two years, the department neglected and has not even paid salary to them. Due to that families are struggling a lot. It is very difficult to maintain families without payment of due salary.

- The NCST vide Notice dated 24.08.2022 had referred the matter to Shri Kantilal Dande, Secretary, Tribal Welfare Department, Government of Andhra Pradesh and Shri Shrikesh B Lathkar, Collector & District Magistrate, District Srikakulam for facts and comments and asked to submit the action taken report within 15 days.
- The Collector and DM Srikakulam vide reply dated 26.09.2022 had stated that the said petitioners are neither recruited nor appointed by the Department. The question of termination or discontinuing services does not arise as they were not at all related to Tribal Welfare Department employees officially as claimed by them. The petitioner had worked voluntarily and knew beforehand that they would only be provided food without any monetary compensation.
- The Tribal Welfare Department, Govt. of Andhra Pradesh vide letter dated 14.12.2022 has furnished the facts and comments and stated that the said petitioners are neither recruited nor appointed by the department, hence the question of termination or discontinuing services does not arise as they were not at all related to Tribal Welfare Department employees officially as claimed by them and the allegation itself is baseless.
- 5. On the sitting held on 03.06.2023, the Commission recommended the following –

List of 67 employees (who have worked as kamati/cooks) to be absorbed through APCOS and action to be taken for their appointment as expeditiously as possible

The reason for not paying equal salary/wages to the kamatis of Seethampeta ITDA and employees of other ITDAs of the state.

The Travelling Allowance of the petitioner for the last 3 sittings to be reimbursed.

The petitioner (Savara Dandasi) is advised to submit the tickets to ITDA, Seethampeta.

Commission that despite assurances no positive action had been taken in the matter yet. Tribal

Welfare Department vide its letter dated 06.09.2024 informed that they have written to Managing Director, APCOS for enabling the necessary registration options to the District Officers in APCOS logins for completing the on boarding of above 347 outsourcing employees. It was also informed that after absorption through APCOS, the remuneration would be increased as well.

- The DM and Collector, Srikakulam sought exemption from personal appearance vide letter dated 06.09.2024 and deputed Shri M. Annadora, District ST Welfare and Empowerment Officer, Srikakulam to appear on his behalf. The Secretary, Tribal Welfare Department, Government of Andhra Pradesh sought exemption from personal appearance and deputed Shri G. Chinna Babu, Assistant Project Officer, ITDA, Seethampeta to appear on his behalf.
- In the sitting, the officers informed that Tribal Welfare Department had written to MD, APCOS to enable the necessary registration options since the government had accorded permission for adjustment of 347 long serving workers. The Commission took a serious view of the delay. The last sitting had been on 10.09.2023 and even after more than a year, the workers had not been registered through APCOS.
- After hearing both the sides, the following is recommended for further appropriate action. The Action taken Report to be submitted within 15 days of receipt of minutes. After receiving of the Action taken Report, the further course of action will be decided in the matter -

The petitioners and other similarly situated persons to be registered through APCOS within 15 days.

- The arrears of the petitioners to be calculated and paid, as per law.
- The Travelling Allowance of the petitioner(s) for the sitting held on 10-09-2024 at NCST to be reimbursed.
- The petitioners (Savara Dandasi and others) are advised to submit the tickets to Project Officer, ITDA, Seethampeta.
